ENROLLED House Bill No. 306

(By Mr. Flannery)

[Passed March 6, 1947; in effect ninety days from passage.]

AN ACT to amend and reenact section seven, article one, chapter twenty-two of the code of West Virginia, one thousand nine hundred thirty-one as amended, relating to the term of office of mine inspectors.

Be it enacted by the Legislature of West Virginia:

That section seven, article one, chapter twenty-two of the code of West Virginia, one thousand nine hundred thirty-one, as amended, be amended and reenacted, to read as follows:

Article 1. Department of Mines.

Section 7. Mining Districts and Divisions; Mine In-2 spectors; Term of Office.—The chief of the department of 3 mines shall divide the state into not less than twenty-five 4 mining districts and not less than three mining divisions 5 so as to equalize as far as practicable the work of each 6 inspector. The chief of the department of mines shall Enr. H. B. No. 306]

appoint one inspector for each mining district within the 7 state, and one mine inspector at large for each division. 8 The mine inspectors in office on the date this code takes 9 effect shall, unless sooner removed as provided by law, 10 11 continue to serve until their terms expire and their suc-12 cessors have been appointed and have qualified. On or after the first day of January, one thousand nine hundred 13 14 forty-two, and on or after the first day of January of each fourth year thereafter, the chief of the department of 15 mines appointed for the term commencing on said first 16 day of January shall appoint one inspector for each min-17 18 ing district within the state, and one mine inspector at 19 large for each division to serve for a term of four years 20commencing on said first day of January.

The chief of the department of mines may assign any person meeting the qualifications of a mine inspector to temporary duty as a mine inspector with the same authority as a mine inspector: *Provided, however,* that in any district where the term of four years as mine inspector is not being served, and persons meeting the qualifications of a mine inspector are available to fill such

vacancy, one of those persons shall be appointed to serve
the term of four years or such portion of the term of four
years as remains to be served as mine inspector, even
though there are persons assigned to temporary duty as
mine inspector in that district.
