House Bill No. 102

(By MR. SPEAKER, MR. FLANNERY, and MR. SEIBERT)

[Passed March 8, 1957; in effect July 1, 1957.]

AN ACT to amend and reenact section four, article nine, chapter fifty-one of the code of West Virginia, one thousand nine hundred thirty-one, as amended, relating to retirement system for judges of courts of record and contributions to retirement fund by judges.

*Be it enacted by the Legislature of West Virginia:*

That section four, article nine, chapter fifty-one of the code of West Virginia, one thousand nine hundred thirty-one, as amended, be amended and reenacted to read as follows:

Section 4. *Percentage Contributions from Salaries.*—

2 Every person who is now serving or shall hereafter serve  
3 as a judge of any court of record of this state shall pay  
4 into the judges' retirement fund six per cent of the salary  
5 received by him either out of the state treasury or from  
6 any county court or courts of this state, or, if his total

7 salary as such judge be paid in part out of the state  
8 treasury and in part by a county court or county courts,  
9 then six per cent of such total salary shall be paid into  
10 the said fund: *Provided*, That when a judge becomes  
11 eligible to receive benefits from said fund no further pay-  
12 ment by him shall be required.

13 In drawing warrants for the salary checks of said  
14 judges, the state auditor shall deduct from the amount of  
15 each such salary check six per cent thereof, which amount  
16 so deducted shall be credited by the state treasurer to said  
17 fund. Where the salary, or any part thereof, of a judge is  
18 paid by a county court, such county court shall deduct  
19 from the amount of each such salary check six per cent  
20 of the amount thereof, which amount so deducted shall  
21 be paid by said county court into the state treasury to  
22 the credit of said fund.
