Senate Bill No. 27

(By Mr. Carson, Mr. President, and Mr. Barnett)

[Passed February 16, 1965; in effect from passage.]

AN ACT to amend and reenact section six, article three, chapter seventeen of the code of West Virginia, one thousand nine hundred thirty-one, as amended, and to provide for the re-evaluation of the state road commission's construction and reconstruction program for the fiscal year one thousand nine hundred sixty-four—sixty-five, and to change from the first day of July of each year to the first day of January of each year the time for the state road commissioner to ascertain and determine the total amount of funds available for road construction and reconstruction for the next succeeding fiscal year; and for the submission of a budget to the appropriate authority by the state road commissioner.

Be it enacted by the Legislature of West Virginia:

That section six, article three, chapter seventeen of the code of West Virginia, one thousand nine hundred thirty-one, as amended, be amended and reenacted to read as follows:

Section 6. Apportionment of State Road Fund for Con-

struction and Reconstruction Purposes; Reserve Fund.— On or before the first day of January of each year the 4 state road commissioner shall ascertain and determine the total amount of available funds for expenditure in the whole state for the construction and reconstruction of state roads for the succeeding fiscal year, and shall also submit such determination of available funds to-9 gether with the proposed expenditure thereof as a part of his budget request for such succeeding fiscal year: 10 Provided, That for the fiscal year one thousand nine hun-11 dred sixty-four—sixty-five the commissioner may re-eval-12 uate the funds available for expenditure for the building 13 and construction of state roads and may present such 14 re-evaluation to the board of public works for inclusion in the budget of the state road commission as a supplemental and deficiency appropriation. Of the amount so

- 18 ascertained the commissioner may set aside as a "reserve
- 19 fund" not to exceed twenty per cent thereof, to be used
- 20 and expended by him in his discretion in making desirable
- 21 connections or economizing in construction.
- 22 All moneys received from the federal government for
- 23 road construction shall be expended as provided, or as
- 24 may hereafter be provided by act of congress.
- 25 If at the end of any annual period, any money in the
- 26 reserve fund remains unexpended or unappropriated, it
- 27 shall be placed in the general fund for reserve and dis-
- 28 tribution during the next annual period.
- 29 The remaining eighty per cent, or, if such reserve fund
- 30 is not set aside, then all the funds shall be appropriated
- 31 in the following order and preference:
- 32 (1) For the construction, reconstruction, maintenance
- 33 of the primary roads, and to comply with the require-
- 34 ments for the receipt of aid from the federal government;
- 35 (2) For the maintenance of all secondary roads, as pro-
- 36 vided in section six-a of this article;
- 37 (3) For the construction and reconstruction of the sec-
- 38 ondary roads as prescribed in section six-a of this article.
