## ENROLLED House Bill No. 609

(By Mr. Auvil)

[Passed February 12, 1970; in effect from passage.]

AN ACT to amend article fourteen, chapter thirty-three of the code of West Virginia, one thousand nine hundred thirty-one, as amended, by adding thereto a new section, designated section twenty-nine, relating to authorizing county boards of education, the teachers retirement board, the West Virginia board of education, and the board of regents and their agencies to establish group tax sheltered annuity plans for the benefit of their employees pursuant to section 403 (b) of the Internal Revenue Code of 1954.

Be it enacted by the Legislature of West Virginia:

That article fourteen, chapter thirty-three of the code of West Virginia, one thousand nine hundred thirty-one, as

amended, be amended by adding thereto a new section, designated section twenty-nine, to read as follows:

## ARTICLE 14. GROUP LIFE INSURANCE.

- §33-14-29. Group annuity plan for employees of county boards of education, the teachers retirement board, the West Virginia board of education, the board of regents and their agencies.
