[Passed March 7, 2006; in effect ninety days from passage.]

AN ACT to amend the Code of West Virginia, 1931, as amended,
by adding thereto a new section, designated §33-6-37,
relating to the cancellation or nonrenewal of combination
insurance policies.

Be it enacted by the Legislature of West Virginia:

That the Code of West Virginia, 1931, as amended, be
amended by adding thereto a new section, designated §33-6-37,
to read as follows:

ARTICLE 6. THE INSURANCE POLICY.

**§33-6-37. Cancellation or nonrenewal of a combination insur-
ance policy; offer of optional coverage; date of
inception of optional coverage.**

1 Notwithstanding of any provision of this chapter to the
2 contrary, an insurer may cancel or nonrenew a combina-
3 tion automobile and homeowners policy of insurance if

4 either the automobile or homeowners insurance in such
5 policy may be cancelled or nonrenewed pursuant to the
6 cancellation or nonrenewal provisions of this chapter
7 pertaining to such insurance: *Provided*, That the insurer
8 shall offer, on a form approved by the commissioner, to
9 issue a policy of insurance, effective as of the date of
10 cancellation of the combination policy, to the insured for
11 the insurance that was not cancelled or nonrenewed and
12 shall issue such policy if the offer is accepted by the
13 insured. For the purposes of cancellation, nonrenewal and
14 termination of policies provided for in articles six-a and
15 seventeen-a of this chapter, the inception date of a re-
16 issued policy is the inception date of the combination policy.
