1 AN ACT to amend the Code of West Virginia, 1931, as amended, by adding thereto a new section,
2 designated §30-29-13, relating to requiring any newly appointed chief executive of a
3 municipal law-enforcement agency to be either a certified law-enforcement officer, or to
4 be certifiable as such, according to the requirements set forth in other applicable
5 provisions of this code; and providing that chief executives employed prior to the effective
6 date are exempt from this requirement.

Be it enacted by the Legislature of West Virginia:


ARTICLE 29. LAW-ENFORCEMENT TRAINING AND CERTIFICATION.

§30-29-13. Chief executive requirements.

1 Notwithstanding any provision of this code to the contrary, on or after July 1, 2018, any
2 person appointed to serve as the chief executive of a municipal law-enforcement agency shall be
3 a certified, or certifiable as, a law-enforcement officer as provided in §30-29-5 of this code:
4 *Provided*, That chief executives of municipal law-enforcement agencies employed prior to July 1,
5 2018, who are not certified law-enforcement officers are exempt from this requirement for
6 purposes of the position he or she holds as of that date.




