ENROLLED BILL

(H. B. No. 189)

[Passed February 9, 1931; in effect ninety days from passage.]

AN ACT to amend and re-enact section seven of chapter one hundred and eight of the acts of the legislature of West Virginia, for one thousand nine hundred twenty-nine, relating to the Butler district high school in the district of Butler, in the county of Wayne and state of West Virginia.

Be it enacted by the Legislature of West Virginia:

That section seven of chapter one hundred eight of the acts of the legislature of West Virginia of one thousand nine hundred twenty-nine, relating to the Butler district high school in the district of Butler, in the county of Wayne and state of West Virginia, be amended and re-enacted so as to read as follows:

Section 7. For the purpose of erecting, building and establishing such high school, the board of directors of said district high school is hereby authorized and empowered to lay a levy for the fiscal year commencing July one, one thousand nine hundred thirty-one, and ending June thirty, one thousand nine

6 hundred thirty-two, and for the fiscal year commencing July
7 one, one thousand nine hundred thirty-two, and ending June
8 thirty, one thousand nine hundred thirty-three, of not exceed-
9 ing thirty cents on each one hundred dollars assessed valuation
10 on all taxable property in said Butler district, and said levy
11 shall be in addition to all other levies now provided by general
12 law for new building and improvement fund purposes, and to
13 be levied in like manner as other levies.

14 And the said board of directors of said district high school is
15 also hereby empowered and authorized to lay such levies as are
16 provided by general law for the purpose of paying the salaries
17 of principals, teachers and other employees necessary for said
18 high school, and for the maintenance, equipment and repairs
19 of said high school.
