## ENROLLED BILL

(S. B. No. 86)

[Passed February 13, 1931; in effect from passage.]

AN ACT to authorize the city of Martinsburg to incur indebtedness and issue bonds in the amount of one hundred thousand dollars for the purpose of refunding indebtedness incurred in improving and extending the water system of said city; making additional improvements thereto, and providing for the payment of bonds so issued and the interest thereon.

*Be it enacted by the Legislature of West Virginia:*

Section 1. Subject to the limitations imposed by the constitution and in conformity with the general laws relating to the issuance of bonds, as contained in article one, chapter thirteen, of the code, the city of Martinsburg is hereby authorized

5 to issue and sell its water works bonds in the amount of one  
6 hundred thousand dollars, and expend the proceeds thereof as  
7 follows: Approximately twenty-six thousand dollars to pay off  
8 and discharge existing indebtedness against the water system  
9 owned by the city; twenty thousand dollars to refund to cer-  
10 tain banking institutions and manufacturing companies money  
11 advanced to the city for the installation of a supply water line  
12 extending to springs owned by the city; two thousand five  
13 hundred dollars for lands for rights-of-way for water lines and  
14 extensions, and the remainder of said one hundred thousand  
15 dollars for the purpose of improving the water system of said  
16 city at such time and in such manner as the council with the  
17 consent and approval of a water commission, representing the  
18 financial and manufacturing interests of the city, appointed  
19 by the council and composed of G. W. F. Mulliss, T. W. Mar-  
20 tin and F. C. Foreman.

Sec. 2. No bonds shall be issued hereunder unless and until  
2 all questions connected with the same shall have been first sub-  
3 mitted to a vote of the people and have received three-fifths  
4 of all the votes cast for and against the same, nor without pro-  
5 viding for a direct annual tax, sufficient to pay annually, the

6 interest on such bonds, and the principal thereof at maturity:  
7 *Provided*, That no part of such direct levy shall be laid unless  
8 the revenue derived from the operation of the water plant shall  
9 prove insufficient to discharge such bonds and interest thereon
