ENROLLED BILL

(H. B. No. 46)

[Passed January 26, 1934 ; in effect 90 days from passage.]

AN ACT to amend and reenact section two, article two, chapter twenty-one of the code of West Virginia, one thousand nine hundred thirty-one, relating to cooperation with the federal government in the establishment of public employment offices.

Be it enacted by the Legislature of West Virginia:

That section two, article two, chapter twenty-one of the code of West Virginia, one thousand nine hundred thirty-one, be amended and reenacted to read as follows:

Section 2. The commissioner of labor may accept cooperation from the federal government in the establishment and maintenance within the state of such employment agency.
The state of West Virginia hereby accepts the provisions and requirements of federal act public number thirty, seventh congress, known as the Wagner-Peyser act, and the state

7 department of labor is hereby designated as the state agency
8 to cooperate with the United States employment service, in ac-
9 cordance with the terms and conditions expressed in the said
10 act. The treasurer of West Virginia is hereby authorized and
11 empowered to receive the grants of money appropriated under
12 said act, and for the purpose of carrying out the provisions
13 of this act the sum of five thousand dollars, or so much thereof
14 as may be necessary, is hereby appropriated for each of the
15 fiscal years ending June thirtieth, one thousand nine hundred
16 thirty-four, and June thirtieth, one thousand nine hundred
17 thirty-five, out of any moneys in the treasury not otherwise
18 appropriated.
