# ENROLLED BILL

(S. B. No. 136)

[Passed March 24, 1934; in effect from passage.]

AN ACT to appropriate money out of the treasury for the purpose of granting relief, in cooperation with the federal government, to the needy citizens of the state.

*Be it enacted by the Legislature of West Virginia:*

Section 1. The general revenue of the state having been supplemented by Title I of "The Supplemental (Emergency) Revenue Act of one thousand nine hundred thirty-four," there is hereby appropriated to the governor, in order to afford relief to the needy citizens of the state, and to gain the advantages of federal cooperation, for the fiscal year one thousand nine hundred thirty-three-one thousand nine hundred thirty-four, the sum of one million dollars to be paid as the governor shall direct, but not to exceed the sum of two hundred fifty

10 thousand dollars in any one month: *Provided, however, That*  
11 two hundred fifty thousand dollars having heretofore been ex-  
12 pended from the state road fund for this purpose in anticipa-

15 four, the governor may repay from this appropriation the sum  
16 of two hundred fifty thousand dollars to the state road  
17 fund.
