## ENROLLED BILL

(H. B. No. 387)

[Passed March 8, 1933; in effect from passage.]

AN ACT to amend and reenact sections ten and thirteen, chapter one, acts of the legislature of West Virginia, regular session, one thousand nine hundred nineteen, entitled "An act to incorporate the town of South Charleston, in Kanawha county, West Virginia, fixing its corporate limits and prescribing and defining the powers and duties of said town and the officers of same."

*Be it enacted by the Legislature of West Virginia:*

That sections ten and thirteen, chapter one, acts of the legislature, regular session, one thousand nine hundred nineteen, be amended and reenacted to read as follows:

Section 10. On the first Tuesday in April, one thousand nine hundred twenty-four, and every four years thereafter, there shall be elected by the qualified voters of said town of South

4 Charleston a mayor, recorder and six councilmen; the term of  
5 office of said mayor, recorder and councilmen shall be for the  
6 period of four years, beginning on the first day of May, next  
7 after their election and until their successors shall be elected  
8 and qualified.

Sec. 13. The first election under this act shall be held on the  
2 first Tuesday in April, one thousand nine hundred thirty-four,  
3 and on the same day every four years thereafter. Such election  
4 and all subsequent elections shall be held in such manner as is  
5 or shall be prescribed by law.

6 All acts and parts of acts inconsistent with any of the pro-  
7 visions of this act are hereby repealed.
