AN_ACT to amend and reenact sections one, two and ten, chapter twenty-six of the acts of the legislature of West Virginia, one thousand nine hundred twenty-five, (municipal charters) creating and relating to the board of park commissioners of the city of Huntington and defining its public duties and powers.

Be it enacted by the Legislature of West Virginia:

That sections one, two and ten, chapter twenty-six of the acts of the legislature of West Virginia, one thousand nine hundred twenty-five (municipal charters) be amended and reenacted so as to read as follows:

Section 1. The city of Huntington in the counties of Cabell
2 and Wayne shall constitute a public park district to be known
3 as the park district of Huntington.

Sec. 2. The board of park commissioners of the city of

2 Huntington shall be a public corporate body, and as such may
3 purchase, hold, sell, or convey, real or personal property, may
4 receive any gift, grant, donation or devise; may sue and be
5 sued or contract and be contracted with, and do other public
6 corporate acts; it shall have the management of and be vested
7 with the title to all real and personal property acquired for the
8 use of the public or useful to the public in the maintenance
9 or enjoyment of all public parks, parkways, playgrounds, ath10 letic fields, swimming pools, cemeteries and boulevards, within
11 the district, and shall manage and dispose of the same as in
12 its opinion will best serve the purpose of this act in the interest
13 of the public.

14 Provided, however, That nothing herein contained shall be
15 construed as limiting the board of park commissioners from
16 going beyond its territorial limits within the state of West
17 Virginia, to lease, purchase or otherwise acquire any real
18 estate for public parks, parkways, playgrounds, athletic fields,
19 swimming pools, cemeteries and boulevards.

20 Provided further, That the board of park commissioners 21 shall be given the right to sell and convey only such part of 22 said real estate as it may acquire by gift or purchase which is CORRECTLY ENROLLED

Sec. 10. The board of park commissioners shall have and is

2 hereby given power to acquire land for a system of public

3 parks, parkways, playgrounds, athletic fields, stadiums, swim-

4 ming pools, cemeteries, boulevards and streets, which it shall

5 determine to be necessary for said public park system, or which

6 it shall determine to be necessary to connect up such system.

7 and if the land necessary for such purposes cannot be acquired

8 by purchase, the power of eminent domain is hereby conferred

9 upon said board of park commissioners of the city of Hunting-

10 ton, and it shall institute condemnation proceedings against

11 the owner thereof under the provisions of chapter fifty-four of

12 the code of West Virginia, one thousand nine hundred thirty-

The term "system of parks, parkways, playgrounds,

14 athletic fields, boulevards and streets" as used herein shall

15 embrace any body of land of whatever shape or area, designated

16 ultimately to be used for public parks, parkways, playgrounds,

17 athletic fields, boulevards or streets, necessary to connect the

18 same within said public park system, and the board of park
19 commissioners shall agree with the municipal authorities of the
20 city of Huntington upon what parts of the streets and boule21 vards are necessary for and are to be used as a part of the
22 public park system within its district.

The board of park commissioners shall have, and is hereby

24 given, the necessary authority to manage and control all public 25 parks, parkways, playgrounds, athletic fields, swimming pools, 26 stadiums, cemeteries, boulevards and streets, used as a part of 27 the public park system within its district, as a means of main-28 taining places of beauty and recreation, promoting the health, 29 property, lives, decency and morality and good order of said 30 independent park district and its inhabitants; and by proper 31 ordinance to regulate the use thereof and driving thereon; to 32 abate, or cause to be abated, all nuisances, and to that end and 33 thereabout to summon witnesses and hear testimony, to regu-34 late or prohibit peddling, selling, merchandising of anything 35 or of any article, goods, wares or merchandise, within said park 36 system as so designated; to regulate or prohibit the placing of 37 signs, bill boards, posters and advertisements within said park 38 system as so designated, or adjacent thereto; to have the same

39 kept in good order and free from obstruction for the use and 40 benefit of the public: to restrain and punish vagrants, mendi-41 cants, beggars, tramps, prostitutes, or disorderly persons on 42 said public parks, parkways, playgrounds, athletic fields, 43 swimming pools, stadiums, cemeteries, boulevards and streets. 44 used as a part of said public park system; but persons arrested 45 under said ordinance shall be tried by the police judge of the 46 city of Huntington, who is hereby given jurisdiction of all 47 warrants issued under any such ordinance: to construct and 48 improve and repair public parks, boulevards, or streets, part 49 of the public park system, parkways, athletic fields, swimming 50 pools, stadiums, cemeteries, roads, bridges, culverts and sewers 51 on any grounds controlled by said board of park commission-52 ers; to acquire, for public use, by lease or otherwise, lands 53 either within or without the city limits as they now exist or 54 such limits as may hereafter be enlarged or diminished; to 55 make contracts with the board of education, the municipal 56 authorities of the city of Huntington, the state authorities, 57 jointly or severally, for the purpose of the construction and 58 erection of a stadium to be used jointly by the school board, 59 Marshall college students and the public under such terms and

60 conditions as the said parties may deem best; to enter into a 61-62 contract with any internal improvement company for the joint 63 ownership of any bridge, to be built by the board of park com-64 missioners and such company; but such bridge shall be a public 65 highway, and the interest of the internal improvement company 66 therein shall be only such a proportionate part thereof which 67 it may pay for; to cause any public boulevard, road, street or 68 alley which is a part of the public park system to be graded or 69 curbed or surfaced with stone, concrete or other suitable mate-70 rials or paved or repaved between curbs with suitable matc-71 rials, or to be graded, surfaced, resurfaced, curbed and re-72 curbed, and paved or repaved, as aforesaid, or to be macad-72-a amized or otherwise permanently improved or repaired in the 73 same manner and to the same extent, as similar power is con-74 ferred upon the board of commissioners of the city of Hunting-75 ton by sections sixty-seven, sixty-eight, sixty-nine and seventy, 76 chapter two, of the acts of the legislature one thousand nine 77 hundred nineteen; to order and cause to be constructed in any 78 public boulevard, street, alley or road, which is a part of said 79 public park system, a public sewer, either main or lateral, in the 80 same manner in which the board of commissioners of the city of

82 of the acts of the legislature, one thousand nine hundred nine-83 teen, and the liens created under the aforementioned sections 84 are to be released and are subject to all the provisions of sec-85 tion seventy-two, chapter two of the acts of the legislature. 86 one thousand nine hundred nineteen; to provide by contract 87 with the municipal authorities of the city of Huntington for 88 the joint construction of sewers, main or lateral, through parks, 89 parkways, cemeteries, playgrounds, athletic fields, boulevards, 90 roads, streets or alleys which are a part of the public park sys-91 tem of the city of Huntington, to be paid for our of joint funds; 92 to provide for the construction and maintenance of a stadium 93 and swimming pools; and to provide the necessary equipment 94 for the use and enjoyment of the public parks and playgrounds 95 of said park system.

Provided, however, That in all of the enumerated powers con-97 tained herein, it shall be the duty of the board of park com-98 missioners of the city of Huntington to so manage and control 99 said public parks, parkways, cemeteries, playgrounds, athletic 100 fields, boulevards, roads, streets or alleys which are a part of 101 the public park system of the city of Huntington, as it may med L.
