ENROLLED House Bill No. 400

AN ACT to amend article eight, chapter thirty-one of the code of West Virginia, one thousand nine hundred thirty-one, by adding thereto a new section designated section 32-b, providing that in the administration by receivers of the assets of insolvent banking institutions having deposits of moneys belonging to the state of West Virginia, no greater rate of interest shall be paid on such deposits than that paid for the same period or periods on the same class or classes of deposits by solvent banking institutions operating in the usual course of business

Be it enacted by the Legislature of West Virginia:

That article eight, chapter thirty-one of the code of West Virginia, one thousand nine hundred thirty-one, be amended by adding

thereto a new section to be designated 32-b, to read as follows:

Section 32-b. Rate of Interest Paid on Deposits of In-

- 2 solvent Banks. In the administration of the assets of in-
- 3 solvent banking institutions by receivers appointed pursuant
- 4 to this article, having deposits of money belonging to the
- 5 state of West Virginia, no greater rate of interest, notwith-
- 6 standing the provisions of the contracts relative to interest
- 7 between such insolvent banking institutions and the state of
- 8 West Virginia, shall be paid on such deposits than that paid
- 9 for the same period or periods on the same class or classes
- 10 of such deposits by solvent banking institutions operating in
- 11 the usual course of business.
