AN ACT to amend and reenact section eleven, article eight, chapter seventeen of the code of West Virginia, one thousand nine hundred thirty-one, relating to traffic regulations and laws of the road.

*Be it enacted by the Legislature of West Virginia:*

That section eleven, article eight, chapter seventeen of the code of West Virginia, one thousand nine hundred thirty-one, be amended and reenacted to read as follows:

Section 11. An operator of a vehicle shall bring the  
2 same to a full stop not less than five feet from any street

3 car or school bus which has stopped to receive or  
4 discharge passengers, and shall remain standing until  
5 such car or school bus has taken on or discharged  
6 such passenger: *Provided, however,* That the operator may  
7 pass such street car or school bus where a safety zone is  
8 established by the proper authorities: *Provided further,*  
9 That the operator, if he slows down and proceeds cautiously,  
10 may pass such street car or school bus at a distance of at  
11 least eight feet therefrom when outside the limits of an  
12 incorporated town or city. Any person driving or oper-  
13 ating a motor vehicle in violation of this section shall be  
14 guilty of a misdemeanor, and upon conviction thereof, shall  
15 be fined not less than ten nor more than one hundred  
16 dollars, or imprisoned in the county jail not less than one  
17 week nor more than six months, or both, in the discretion  
18 of the court or justice trying the case.
