AN ACT to authorize the board of public works to provide for and maintain developments upon and adjacent to the grounds of the state capitol, to the extent that moneys for the purpose may be appropriated; and to authorize the appointment of an advisory committee to advise with and assist the board in the preparation of plans for such development.

*Be it enacted by the Legislature of West Virginia:*

Section 1. To the extent that moneys may be appropriated  
2 for the purpose, the board of public works is hereby author-  
3 ized to provide for and maintain developments upon and ad-  
4 jacent to the grounds of the state capitol, including among

5 such development: Streets, sidewalks, driveways, paths, land-  
6 scaping, ornamentation, and memorial structure. The board  
7 may employ architects and landscape gardeners.

Sec. 2. The governor is hereby authorized to appoint an  
2 advisory committee of not more than five members to advise  
3 with and assist the board of public works in the planning of  
4 the developments contemplated in section one of this act.  
5 The governor shall designate one member of the committee  
6 as chairman. The committee shall select one of its own mem-  
7 bers as secretary. It shall meet as and when requested by  
8 the governor, and shall render such advice and assistance as  
9 the board of public works may, under the purpose of this act,  
10 request.

11 The members of the committee shall receive no compensa-  
12 tion for their services, but may be allowed their expenses  
13 actually incurred in the performance of their duties as mem-  
14 bers, when upon sworn and itemized requisition signed by  
15 the chairman.
