AN ACT to amend and reenact section one, article two, chapter one of the code of West Virginia, one thousand nine hundred thirty-one, apportioning the membership in the state senate of West Virginia.

*Be it enacted by the Legislature of West Virginia:*

That section one, article two, chapter one of the code of West Virginia, one thousand nine hundred thirty-one, be amended and reenacted to read as follows:

Section 1. The state shall consist of sixteen senatorial  
2 districts as follows:

3 The counties of Brooke, Hancock and Ohio shall constitute  
4 the first senatorial district;

5 The counties of Marshall, Tyler and Wetzel shall con-  
6 stitute the second senatorial district;

7 The counties of Calhoun, Gilmer, Pleasants, Ritchie, Wirt  
8 and Wood shall constitute the third senatorial district;

9 The counties of Clay, Jackson, Mason, Putnam and Roane  
10 shall constitute the fourth senatorial district;

11 The counties of Cabell and Wayne shall constitute the fifth  
12 senatorial district;

13 The counties of McDowell and Mingo shall constitute the  
14 sixth senatorial district;

15 The counties of Boone, Lincoln and Logan shall constitute  
16 the seventh senatorial district;

17 The county of Kanawha shall constitute the eighth sena-  
18 torial district;

19 The counties of Raleigh and Wyoming shall constitute the  
20 ninth senatorial district;

21 The counties of Mercer, Monroe and Summers shall con-  
22 stitute the tenth senatorial district;

23 The counties of Fayette and Greenbrier shall constitute  
24 the eleventh senatorial district;

25 The counties of Braxton, Nicholas, Pendleton, Pocahontas,  
26 Randolph and Webster shall constitute the twelfth senatorial  
27 district:

28 The counties of Doddridge, Harrison and Lewis shall con-  
29 stitute the thirteenth senatorial district;

30 The counties of Marion, Monongalia and Taylor shall con-  
31 stitute the fourteenth senatorial district;

32 The counties of Barbour, Grant, Preston, Tucker and  
33 Upshur shall constitute the fifteenth senatorial district;

34 The counties of Berkeley, Hampshire, Hardy, Jefferson,  
35 Mineral and Morgan shall constitute the sixteenth senatorial  
35a district.

36 Each of the said districts shall have two senators, and,  
37 regardless of the changes in district lines made by this act,  
38 the senators elected at the last general election shall con-  
39 tinue to hold their seats as members of the senate for the  
40 term for which each thereof, respectively, was elected.

41 The first, second, third, fourth, fifth, tenth, eleventh, thir-  
42 teenth, fourteenth, fifteenth and sixteenth districts as herein

43 designated shall, at the general election to be held in the  
44 year one thousand nine hundred thirty-eight, and biennially  
45 thereafter, elect one senator for a term of four years.

46 At the general election to be held in the year one thou-  
47 sand nine hundred thirty-eight there shall be two senators  
48 elected in each of the sixth, eighth and ninth senatorial dis-  
49 tricts, as herein designated, one of whom from each district  
50 shall be nominated and elected for a term of two years  
51 and one of whom shall be elected for a term of four years,  
52 and biennially thereafter one senator shall be elected in each  
53 of the senatorial districts for a term of four years.

54 There shall be held no election for senator in the seventh  
55 and twelfth senatorial districts as herein designated, until  
56 the general election held in the year one thousand nine  
57 hundred forty, at which time there shall be elected from  
58 the said seventh and twelfth senatorial districts, as herein  
59 designated, two senators, one of whom shall be nominated  
60 and elected for a term of two years and the other nominated  
61 and elected for a term of four years, and biennially there-  
62 after one senator shall be elected in the said districts for  
63 a term of four years.

64 All acts, or parts of acts, in conflict with this act, or  
65 with any part thereof, are hereby repealed.
