AN ACT to permit the county court of Braxton county, with the consent of the holders of certificates of indebtedness, to post-pone the payment of such certificates, and to employ and use the levy therefor along with any surplus in said fund, existing or arising, in the construction of additions, repairs and reconditioning of the county courthouse and jail.

Be it enacted by the Legislature of West Virginia:

Section 1. The county court of Braxton county, by and

- 2 with the consent of the holders of the certificates of in-
- 3 debtedness issued by said court, dated January first, one
- 4 thousand nine hundred thirty-five, and payable June first,
- 5 one thousand nine hundred thirty-seven, under the pro-

- 6 visions of chapter sixty-four, acts of the legislature, second
- 7 extraordinary session, one thousand nine hundred thirty-
- 8 three, is hereby authorized and empowered to postpone the
- 9 payment of such certificates until the first of June, one
- 10 thousand nine hundred forty, and interest shall be paid
- 11 thereon at the rate provided for therein from the due date
- 12 thereof until payment.
 - Sec. 2. The said county court of Braxton county is here-
 - 2 by authorized and empowered to expend the amount levied
 - 3 by it for the fiscal year ending June thirty, one thousand
 - 4 nine hundred thirty-seven, for contractual debt purposes,
 - 5 together with any other moneys now in the contractual debt
 - 6 fund derived from other sources, in providing for additions
 - 7 and repairs to the courthouse and jail of said county; and
 - 8 such moneys may be so expended in conjunction with any
 - 9 moneys allocated in aid of such purposes by the govern-
- 10 ment of the United States, or any agency established by it,
- 11 or independently thereof.
 - Sec. 3. The said county court of Braxton county shall
 - 2 make provision for the payment of the certificates of in-
- 3 debtedness, the payment of which may be postponed under

- 4 the provisions of this act, by levies for the fiscal year end-
- 5 ing June thirty, one thousand nine hundred forty.
- 6 All acts or parts of acts in conflict herewith are hereby
- 7 repealed.

I certify that the foregoing act, taving been presented to the Governor for his approval, and not having been returned by him to the House of the Legislature in which it originated within the time prescribed by the constitution of the state, has become a law without his approval.
