
## WEST VIRGINIA LEGISLATURE

**REGULAR SESSION, 1937** 



ENROLLED House Bill No. 239 (By Mr. White)

[Passed February 25, 1937; in effect from passage.]

AN ACT to amend and reenact section eleven, article eight, chapter thirty-one of the code of West Virginia, one thousand nine hundred thirty-one, relating to reports of banking institutions and the publication of such reports.

Be it enacted by the Legislature of West Virginia:

That section eleven, article eight, chapter thirty-one of the code of West Virginia, one thousand nine hundred thirty-one, relating to reports of banking institutions and the publication of such reports, be amended and reenacted to read as follows:

Section 11. Reports of Banking Institutions; Publication;
2 Reports to Be in Detail. Every banking institution organ3 ized and authorized to transact business under this chapter
4 shall make at least four reports each year to the commissioner

5of banking. Such reports shall be called for as nearly as 6 conveniently may be on the dates on which the comptroller 7 of the currency shall call for reports by national banking associations, and be of such form and contain such details as 8 9 shall be prescribed by the commissioner of banking; which 10 reports shall be verified by the oath of the president or active 11 vice president and cashier, and attested by the signature of at least three directors of the banking institution. Each re-12 13 port shall show in detail, under appropriate heads, the re-14 sources and liabilities of the banking institution at the close 15 of the business on the date specified by the banking commis-16 sioner, and shall be transmitted to the office of the depart-17 ment of banking and supervision within five days from the receipt of the request for the same. 18

19 Such report, in the same form in which it is made to the 20 commissioner of banking, shall be published in a newspaper 21 printed in the place where the banking institution is located 22 first or nearest thereto; or if no newspaper is printed in such 23 location, it shall be published in a newspaper printed in the 24 same county and of general circulation in the community 25 where the banking institution is located.

In lieu of such report and publication, the commissioner 26of banking shall have discretion to accept from a banking 27 institution which is a member of the federal reserve system 28 a report, and the publication thereof required of such bank-29 ing institution by the federal reserve board, or by its agency: 30 Provided, That such report shall show in detail, under ap-31 propriate heads, the resources and liabilities of the banking 32 institution at the close of business on the day specified by the 33 federal reserve board, or by its agency, and shall contain 34such further details as may be deemed necessary or desirable 35 by the commissioner of banking. 36

Any report and the publication thereof shall be at the expense of the banking institution, and it shall furnish to the commissioner of banking such proof of the publication as may be required by him.

> I certify that the foregoing act, naving been presented to the Governor for his approval, and not having been returned by him to the House of the Legislature in which it originated within the time prescribed by t! e constitution of the state, has become a law without his approval.
