AN ACT to amend and reenact section twenty-six, article four, chapter seventeen of the code of West Virginia, one thousand nine hundred thirty-one, as amended by chapter forty, acts of the Legislature of West Virginia, first extraordinary session, one thousand nine hundred thirty-three, relating to bridges.

Be it enacted by the Legislature of West Virginia:

That section twenty-six, article four, chapter seventeen of the code of West Virginia, one thousand nine hundred thirty-one, as amended by chapter forty, acts of the Legislature of West Virginia, first extraordinary session, one thousand nine hundred thirty-three, be amended and reenacted to read as follows:

Section 26. *Commissioner to Designate and Relocate Bridge*

2 *in Municipal Corporation.* The state road commissioner shall

3 designate and may, at any time, relocate and redesignate as
4 a connecting part of a primary road, any bridge or street
5 within a municipal corporation. The commissioner shall con-
6 struct, reconstruct, improve and maintain the designated con-
7 necting part at the cost and expense of the state: *Provided*,
8 *however*, That any existing free bridge forming a connecting
9 link between two counties and two state routes, is hereby
10 adopted as part of the state road system and shall hereafter
11 be maintained by the state: *Provided further*, That any ex-
12 isting free bridge forming a connecting link as an interstate
13 bridge between this state and another state is hereby adopted
14 as part of the state road system, and as to that part of the
15 bridge within the boundary of this state shall be maintained
16 by the state.


