AN ACT to amend article eight, chapter thirty-one of the code of West Virginia, one thousand nine hundred thirty-one, as amended by chapters five and seven, acts of the Legislature, first extraordinary session, one thousand nine hundred thirtythree, by adding a new section to said article to be designated as section forty-five, relating to banking institutions incorporated under the laws of the state of West Virginia whose business is solely conducted outside the limits of this state.

Be it enacted by the Legislature of West Virginia:

That article eight, chapter thirty-one of the code of West Virginia, one thousand nine hundred thirty-one, as amended by chapters five and seven, acts of the Legislature, first extraordinary session, one thousand nine hundred thirty-three, be amended by

adding a new section to said article to be designated section fortyfive, to read as follows:

Section 45. Banking Institutions Incorporated Under Laws of This State Whose Business Is Conducted Entirely Out-2 side State. Any banking institutions, incorporated under the 3 laws of this state, all of whose business is conducted entirely 4 5 outside of the state of West Virginia, shall not be subject to 6 supervision by the department of banking or the commis-7 sioner of banking, and shall not be required to make any reports to it or him, or to publish such reports, and no con-8 sent or authority of the commissioner shall be necessary or 9 required as to any of the acts and practices of said non-resi-10 11 dent banks in and about the conduct of their business outside of the state of West Virginia, and the commissioner of 12 banking shall not be responsible for any acts or practices of 13 14 said non-resident banks. The officers and directors of such non-resident banking institutions may all be non-residents 15 16 of the state of West Virginia, and such non-resident banking 17 institutions may conduct the banking business at such place 18 or places outside of the state of West Virginia as they may 19 be permitted under the laws of the jurisdiction in which such

The restrictions in the banking 21 laws of this state contained as to establishment and maintenance of branch banks shall not be applicable to said non-22 resident banks, but no non-resident bank shall operate or 23 24 maintain any branch bank in this state. The provisions, re-25 quirements, restrictions and limitations in the banking laws contained relative to the capital stock, either authorized or 26 27 issued, and to the increase thereof, to the acquisition and 28 holding of real estate, to the oath and qualifications of direc-29 tors, to loans and the property, real or personal, upon the 30 security of which loans may be made, to the borrowing of 31 money by banking institutions and the hypothecation of 32 securities or other property for the same, to reserves, and to 33 dividends and all other restrictions and limitations of the 34 banking laws of this state, shall not apply to said non-resident banks: Provided, however, That nothing in this act shall be 35 36 construed as relieving said non-resident banks from compli-37 ance with the laws of the jurisdiction in which they may con-38 duct business: Provided, further, That this section shall not 39 apply to any banking institution, any part of whose actual

And provided further, That nothing in this section contained 41 42 shall be interpreted as rendering any laws now in force or 43 hereafter enacted inapplicable to banking institutions doing 44 any actual business in the state of West Virginia, and such future legislation, unless it specifically or by necessary im-4546 plication appear to the contrary, shall be construed as ap-47 plicable only to banking institutions having a place of business in the state of West Virginia. 48
