[Passed March 11, 1939; in effect from passage.]

AN ACT to amend and reenact section one, article four, chapter thirty-five of the code of West Virginia, one thousand nine hundred thirty-one, relating to disposition of property of subordinate fraternal lodge on dissolution.

Be it enacted by the Legislature of West Virginia:

That section one, article four, chapter thirty-five of the code of West Virginia, one thousand nine hundred thirty-one, be amended and reenacted to read as follows:

Article 4. Provisions Regarding Particular Fraternal Organizations.


Section 1. *Odd Fellows and Knights of Pythias; Disposition of Property of Subordinate Lodge on Dissolution.* If any subordinate lodge of either the Independent Order of Odd Fellows or the order Knights of Pythias, in this state, working

5 under the respective jurisdictions of the parent grand lodge
6 of said respective orders, for this state, shall disband, sur-
7 render or forfeit its charter and cease to work, all its prop-
8 erty, real and personal, shall, immediately upon such dis-
9 banding, surrender or forfeiture, vest in the said respective
10 parent grand lodge, having jurisdiction over said subordinate
11 lodge, to be held by that body for the charitable uses of the
12 said respective parent grand lodge, in this state, according
13 to the rules, regulations and policy of the grand lodge con-
14 cerned, and said respective parent grand lodge is authorized
15 in its corporate name, to sue for and recover such property,
16 real and personal.

I certify that the foregoing act,
having been presented to the Governor for
his approval, and not having been returned
by him to the House of the Legislature in
which it originated within the time pre-
scribed by the constitution of the state, has
become a law without his approval.
