AN ACT authorizing the state road commissioner to refund to the county court of Nicholas county any and all moneys erroneously paid by said county court, or the sheriff of said county, to the state road commission under and by virtue of the provisions of chapter fifty-nine, acts of the Legislature of West Virginia, first extraordinary session, one thousand nine hundred thirty-three, or chapter forty-two, acts of the Legislature of West Virginia, second extraordinary session, one thousand nine hundred thirty-three.

*Be it enacted by the Legislature of West Virginia:*

Section 1. *State Road Commission Authorized to Refund*  
2 *Moneys to Nicholas County Court.* The state road commis-  
3 sioner is hereby authorized to refund to the county court of  
4 Nicholas county any and all moneys which may have been

5 erroneously paid to the state road commission by said county  
6 court, or by the sheriff of said county, under and by virtue  
7 of the provisions of chapter fifty-nine, acts of the Legislature  
8 of West Virginia, first extraordinary session, one thousand  
9 nine hundred thirty-three, or chapter forty-two, acts of the  
10 Legislature of West Virginia, second extraordinary session,  
11 one thousand nine hundred thirty-three, not to exceed the  
12 sum of ten thousand eight hundred forty-nine dollars forty-  
13 four cents. Any and all refunds made under the authority  
14 herein given shall be held on account of and placed to the  
15 credit of the general county fund of said county, and shall  
16 be used only for the retirement of outstanding indebtedness  
17 existing against the several road funds of said county at  
18 the time of said payment to the state road commission or  
19 for reimbursing said general county fund on account of any  
20 payments heretofore made therefrom on account of such  
21 indebtedness.
