Senate Bill No. 135

(BY MR. ALLEN)

[Passed February 15, 1939; in effect from passage.]

AN ACT to permit the county court of Webster county, with the consent of the holders of certificates of indebtedness, to postpone the payment of such certificates, and to employ and use the levies therefor along with any surplus in said fund, existing or arising, in the construction of additions, repairs and reconditioning of the county courthouse and jail.

Be it enacted by the Legislature of West Virginia:

Section 1. *Webster County Court Authorized to Postpone*
2 *Payment of Certificates of Indebtedness.* The county court
3 of Webster county, by and with the consent of the holders

4 of the certificates of indebtedness issued by said court,
5 dated January first, one thousand nine hundred thirty-five,
6 and payable June first, one thousand nine hundred thirty-
7 nine, one thousand nine hundred forty, one thousand nine
8 hundred forty-one, one thousand nine hundred forty-two,
9 one thousand nine hundred forty-three, and one thousand
10 nine hundred forty-four, respectively, under the provisions
11 of chapter sixty-four, acts of the Legislature, second extra-
12 ordinary session, one thousand nine hundred thirty-three,
13 is hereby authorized and empowered to postpone the pay-
14 ment of such certificates until the first of June, one thousand
15 nine hundred forty-five, one thousand nine hundred forty-
16 six, one thousand nine hundred forty-seven, one thousand
17 nine hundred forty-eight and one thousand nine hundred
18 forty-nine, respectively; and in order to obviate the neces-
19 sity of making levies in any one fiscal year for the payment
20 of both the certificates actually falling due that year and the
21 certificates postponed for payment to that year, the said
22 county court of Webster county is further authorized and
23 empowered, by and with the consent of the holders of such
24 certificates, to extend the payment of such certificates, the


25 payment of which not having been theretofore postponed in
26 accordance with this act, falling due in one thousand nine
27 hundred forty-five and each successive year thereafter in
28 which said certificates are payable, for a period of four years
29 beyond the due date thereof; and interest shall be paid
30 thereon at the rate provided for therein from the due date
31 thereof until payment.

Sec. 2. *Expenditure of Contractual Debt Levies on Court-*
2 *house and Jail.* The said county court of Webster county is
3 hereby authorized and empowered to expend the amount to
4 be levied by it for the fiscal years ending June thirty, one
5 thousand nine hundred forty, one thousand nine hundred
6 forty-one, one thousand nine hundred forty-two, one thou-
7 sand nine hundred forty-three, and one thousand nine hun-
8 dred forty-four, respectively, for contractual debt purposes,
9 together with any other moneys now in the contractual debt
10 fund as a balance therein from whatever source derived,
11 in providing for the construction of additions and repairs to
12 and the reconditioning of the courthouse and jail of said
13 Webster county; and such moneys may be so expended in
14 conjunction with any moneys allocated in aid of such pur-

15 poses by the government of the United States, or any agency
16 established by it, or independently thereof; and the said
17 county court of Webster county is hereby further authorized
18 and empowered, in order to have the present benefit of said
19 future contractual debt levies, to pledge the same for the
20 said years of one thousand nine hundred forty, one thousand
21 nine hundred forty-one, one thousand nine hundred forty-
22 two, one thousand nine hundred forty-three and one thou-
23 sand nine hundred forty-four, respectively.

Sec. 3. *When Levies to be Laid for Payment of Certificates*
2 *of Indebtedness.* The said county court of Webster county
3 shall make provision for the payment of the certificates of in-
4 debtedness, the payment of which may be postponed under
5 the provisions of this act, by levies for the fiscal year ending
6 June thirty, one thousand nine hundred forty-five and every
7 successive year thereafter to which the payment of said cer-
8 tificates was postponed.

I certify that the foregoing act, 
having been presented to the Governor for
his approval, and not having been returned
by him to the House of the Legislature in
which it originated within the time pre-
scribed by the constitution of the state, has
become a law without his approval.
