AN ACT to amend and reenact sections two and three, article seven, chapter seven of the code of West Virginia, one thousand nine hundred thirty-one, as amended and reenacted by chapter nineteen, acts of the Legislature of West Virginia, extraordinary session, one thousand nine hundred thirty-two and as further amended and reenacted by chapter eighty-three, acts of the Legislature of West Virginia, regular session, one thousand nine hundred thirty-seven, relating to the salaries of clerks of the county courts and clerks of the circuit courts.

Be it enacted by the Legislature of West Virginia:

That sections two and three, article seven, chapter seven of the

code of West Virginia, one thousand nine hundred thirty-one, as amended and reenacted by chapter nineteen, acts of the Legislature of West Virginia, extraordinary session, one thousand nine hundred thirty-two and as further amended and reenacted by chapter eighty-three, acts of the Legislature of West Virginia, regular session, one thousand nine hundred thirty-seven, be amended and reenacted to read as follows:
