# House Bill No. 275

(By Mr. Boggs)

[Passed March 8, 1941; in effect from passage.]

AN ACT to authorize the county court of Clay county, West Virginia, to lay a levy and use the proceeds therefrom for the general repair of the county jail and general repair of the courthouse and courthouse yard and the purchase of necessary furniture, said levy to be laid for a period of three years.

*Be it enacted by the Legislature of West Virginia:*

Section 1. The county court of Clay county, West Virginia, shall be, and is hereby, authorized to levy, use and expend for the purpose of making general repairs to the county jail and certain equipment, and general repairs to the courthouse and court yards, and necessary furniture and the levies heretofore apportioned to the said county for the purpose of paying the principal and interest and

8 providing of sinking fund for the general repairs for  
9 county jail, courthouse and necessary furniture and  
10 equipment. The proceeds derived from said levy shall  
11 be used in repairs of said county jail, courthouse, and  
12 the funds shall be designated as "General County Repair  
13 Funds": *Provided, however,* That the principal of said  
14 levy so laid shall not exceed the sum of thirty-five hundred  
15 dollars to be levied over a period of three years. When  
16 said levy is so laid by the county court, the approval in  
17 writing of the state tax commissioner shall be necessary.

Sec. 2. The said county court shall contract for the  
2 general repair of the county jail and shall include in the  
3 repair contract for the equipment of new locks on all  
4 inside and outside doors and other hardware necessary to  
5 provide the most modern locks for all inside and outside  
6 cell doors, also necessary plumbing, etc., and to provide  
7 for the necessary repairs to the exterior walls and other  
8 general repairs as may be deemed necessary to provide  
9 a first class jail. Of the sum of thirty-five hundred dol-  
10 lars the sum of twenty-three hundred dollars of this  
11 amount shall be used for the above purposes.

Sec. 3. Of the remaining twelve hundred dollars, the  
2 county court is authorized to expend the remainder herein  
3 provided, for the purpose of general repairs to the court-  
4 house in the way of replacing broken glass and windows,  
5 where needed, repair of spouting and drains on building,  
6 painting window sashes, including all outside doors and  
7 windows, providing sufficient venetian blinds for all the  
8 windows, beautifying the court yard, provide flower beds  
9 for the court yard, making repairs for the steps leading  
10 from street to courthouse and also provide for the clean-  
11 ing out and opening of water wells and provide sufficient  
12 steps and platforms to make it convenient for the public  
13 to secure drinking water; and, in fact, to use and expend  
14 said money efficiently for general repairs of the building  
15 and grounds. It shall be mandatory on the county court  
16 to carry out this provision as to the beautifying and  
17 general repairs of the courthouse if the court provides  
18 for the general repair of the jail; in fact, one is predicated  
19 on the other.
