House Bill No. 230

[Passed March 10, 1943; in effect from passage.]

AN ACT to amend article four, chapter sixteen of the code of West Virginia, one thousand nine hundred thirty-one, by adding thereto four new sections to be designated sections twenty-seven, twenty-eight, twenty-nine and thirty, relating to the custody, detention and treatment of persons suffering from venereal diseases.

Be it enacted by the Legislature of West Virginia:

That article four, chapter sixteen of the code of West Virginia, one thousand nine hundred thirty-one, be amended by adding thereto four new sections to be designated sections twenty-seven, twenty-eight, twenty-nine and thirty, to read as follows:

Article 4. Venereal Diseases.

*Section 27. Additional Power and Authority of Local
2 Health Officers.*—The local health officer, in exercising

3 any of the powers or authority vested in him by sec-
4 tions nine, ten, eleven, twelve, sixteen and twenty-one
5 of this article with respect to any patient, minor or
6 other person suffering or believed by him to be suffer-
7 ing from any venereal disease or diseases, may forth-
8 with cause any such patient, minor or other person to
9 be delivered into the custody of the state department
10 of health for detention and treatment as provided in
11 this article.

Sec. 28. *Detention Places.*—The state department of
2 health is hereby authorized and empowered to estab-
3 lish and provide a suitable place or places in the state
4 of West Virginia for the detention of persons found to
5 be suffering from any of the venereal diseases defined in
6 section one of this article and to supervise, use and
7 maintain such place or places in a manner deemed neces-
8 sary or desirable in carrying out the provisions of this
9 article.

Sec. 29. *Detention and Treatment.*—There shall be ac-
2 cepted and received into the custody of the state de-
3 partment of health at such place or places provided for

4 in the next preceding section, persons found upon in-
5 vestigation and examination to be suffering from venereal
6 diseases as defined in section one of this article, for the
7 purpose of detention and necessary medical attention and
8 treatment thereat or therein, until found to be and pro-
9 nounced cured of the venereal disease or diseases from
10 which they are suffering.

Sec. 30. *Continuous Jurisdiction.*—The state depart-
2 ment of health is vested with and given continuous juris-
3 diction, authority and control over all persons received
4 at and to be detained in or on the place or places pro-
5 vided for in the preceding sections, for all the purposes
6 of this article, and until such persons are found upon
7 proper examination to be and pronounced entirely free
8 from and cured of any venereal disease or symptoms of
9 such disease existing.
