ENROLLED House Bill No. 379

(By Mr. LaFollette)

[Passed March 13, 1943; in effect from passage.]

AN ACT to amend article four, chapter eleven-a of the code of West Virginia, one thousand nine hundred thirty-one, as enacted by chapter one hundred seventeen, acts of the Legislature, regular session, one thousand nine hundred forty-one, by adding thereto a new section to be numbered fifty-six, relating to disposition of sheriff's lists and sale of real estate for taxes.

Be it enacted by the Legislature of West Virginia:

That article four, chapter eleven-a of the code of West Virginia, one thousand nine hundred thirty-one, as enacted by chapter one hundred seventeen, acts of the Legislature, regular session, one thousand nine hundred forty-one, be amended by adding thereto a new section to be numbered section fifty-six, to read as follows:

Section 56. In the event any part of this chapter be

- 2 declared to be unconstitutional to the end that the state
- 3 can not adequately dispose of real estate which is de-
- 4 linquent for nonpayment of taxes, forfeit for nonentry,
- 5 waste and unappropriated, escheated, or purchased by
- 6 the state whether redeemed or unredeemed and subject
- 7 to sale for the benefit of the school fund or which may
- 8 have been certified to and is now in the hands of the
- 9 auditor, the auditor shall complete his compilation of
- 10 such lands from any appropriations now or hereafter
- 11 made for the purpose and shall hold the same pending
- 12 future directions and an enactment of statutes by the
- 13 Legislature respecting the disposition thereof, and the
- 14 auditor in such event shall direct any and all deputy
- 15 commissioners to recertify to him any lands which may
- 16 be in their hands for disposal.
