AN ACT to amend article two, chapter six of the code of West Virginia, one thousand nine hundred thirty-one, as amended, by adding thereto a new section, numbered section nineteen-a, relating to bonds of employees and deputies of the tax commissioner's office.

*Be it enacted by the Legislature of West Virginia:*

That article two, chapter six of the code of West Virginia, one thousand nine hundred thirty-one, as amended, be amended by adding thereto a new section, numbered section nineteen-a, to read as follows:

Section 19-a. *Bonds of Employees and Deputies of the*  
2 *Tax Commissioner's Office.* The tax commissioner shall  
3 require every employee and deputy who collects fees  
4 or handles funds, or who has custody of equipment, sup-  
5 plies, and other property belonging to the state, to take  
6 the oath prescribed by section five, article four of the  
7 state constitution; and he shall require every employee  
8 and deputy to furnish, or he shall himself obtain, a bond,  
9 insurance policy, indemnity contract, or other contract,  
10 protecting and indemnifying the state against any and  
11 all loss or damage that may be occasioned by the failure  
12 of the employee or deputy faithfully to perform the  
13 duties pertaining to his employment, and to account for,  
14 pay over and deliver to the proper officer or agent of the  
15 tax commissioner or state all moneys and other property  
16 which may come into his custody or under his control by  
17 virtue of his employment. Such bond, insurance policy,  
18 indemnity contract, or other contract, shall be in such  
19 form, and in such sum, and with such security, as may be  
20 prescribed or approved by the tax commissioner, and may  
21 cover any one employee or deputy or any number of em-

22 ployees or deputies. The premiums for all such bonds,  
23 insurance policies, indemnity contracts, or other contracts,  
24 shall be paid by the tax commissioner.
