AN ACT to amend and reenact section four, chapter twenty-seven, acts of the Legislature of West Virginia, regular session, one thousand nine hundred and nine; as amended and reenacted by section four, chapter twelve, acts of the Legislature, regular session, one thousand nine hundred nineteen; as amended and reenacted by section four, chapter one hundred forty-six, acts of the Legislature, regular session, one thousand nine hundred twenty-nine; as amended and reenacted by section four, chapter twenty-seven, acts of the Legislature, extraordinary session, one thousand nine hundred thirty-two, and as last amended by section twenty-one, chapter eighty-two, acts of the Legislature, regular session, one thousand nine hundred thirty-seven, all relating to the salary of the judge of the criminal court of Harrison county.

Be it enacted by the Legislature of West Virginia:

That section four, chapter twenty-seven, acts of the Legislature of West Virginia, regular session, one thousand nine hundred nine, as amended and reenacted by section four, chapter twelve, acts of the Legislature, regular session, one thousand nine hundred nineteen, as amended and reenacted by section four, chapter one hundred forty-six, acts of the Legislature, regular session, one thousand nine hundred twenty-nine, as amended and reenacted by section four, chapter twenty-seven, acts of the Legislature, extraordinary session, one thousand nine hundred thirty-two, and as last amended by section twenty-one, chapter eighty-two, acts of the Legislature, regular session, one thousand nine hundred thirty-seven, be amended and reenacted to read as follows:

Section 4.—The judge of the criminal court of Harrison
2 county, West Virginia, shall, from the effective date here-
3 of, receive for his services a salary of five thousand dollars
4 per year; said amount to be paid in twelve equal monthly
5 installments from year to year by the county court of
6 said county, out of funds of said county, in the manner
7 provided by statute.
