AN ACT to amend article two, chapter twenty-seven of the code of West Virginia, one thousand nine hundred thirty-one, as amended, by adding thereto a new section, to be designated section seven, relating to the transfer of Barboursville Unit of Weston State Hospital to Huntington State Hospital.

Be it enacted by the Legislature of West Virginia:

That article two, chapter twenty-seven of the code of West Virginia, one thousand nine hundred thirty-one, as amended,

be amended by adding thereto a new section, designated section seven, to read as follows:

Section 7. Effective the first day of July, one thousand
2 nine hundred forty-five, the operation of the Barbours-
3 ville unit of Weston state hospital shall be transferred by
4 the board of control in such manner that thereafter the
5 said Barboursville unit shall be operated as a part of
6 Huntington state hospital. The board of control is em-
7 powered to take all such steps and do all such things as
8 may be necessary and proper to effect such transfer, in-
9 cluding transfer of property and other like accounts from
10 Weston state hospital to Huntington state hospital.

11 Nothing herein contained shall in any wise impair the
12 rights and powers vested in the board of control by law
13 with respect to state institutions. Appropriations now or
14 hereafter made for the operations of said Barboursville
15 unit shall be used for its maintenance and operation with-
16 out regard to the transfer required hereunder.
