AN ACT to emend and reenact chapter one hundred thirty-seven, acts of the Legislature of West Virginia, regular session, one thousand nine hundred forty-five, relating to the disposition of balances remaining in funds realized from the Federal Army, Navy and Civil Aeronautics Trainee Program in various state educational institutions.

Be it enacted by the Legislature of West Virginia:

That chapter one hundred thirty-seven, acts of the Legislature of West Virginia, regular session, one thousand nine hundred forty-five, be amended and reenacted to read as follows:

Section 1. *Application of the Net Proceeds from the*
2 *Federal Army, Navy and Civil Aeronautics Trainee Pro-*
3 *gram at West Virginia University and the State Colleges*
4 *of West Virginia.*—The entire net proceeds derived from

5 the Federal Army, Navy and Civil Aeronautics Trainee
6 Program at West Virginia University, West Virginia In-
7 stitute of Technology, Marshall College, Shepherd Col-
8 lege, Concord College, Fairmont State College and West
9 Virginia State College shall be expended respectively by
10 such institutions upon the approval of the board of gov-
11 ernors for West Virginia University as to that institution,
12 and upon the approval of the West Virginia board of
13 control as to all the other institutions named herein, for
14 the renovation and repair of buildings, for the replace-
15 ment of furniture and equipment, for the restoration of
16 property damaged as a result of such trainee programs,
17 or for the purpose of providing necessary facilities or
18 personnel for the accommodation and instruction of re-
19 turning veterans and others enrolled at such institutions.
20 Any unexpended funds heretofore collected by these in-
21 stitutions, whether heretofore paid and reported to the
22 state or otherwise, and any funds hereafter collected
23 and derived from such sources by each such institution,
24 shall be placed and kept in a special fund to the credit of
25 such institution so reporting or collecting the same, and

26 shall be expended by the board of governors for West
27 Virginia University for that institution, and shall be ex-
28 pended by the board of control for each of the other
29 institutions so reporting or collecting for the purposes
30 herein enumerated.

Sec. 2. *Duration of Act.*—The provisions of this act
2 shall be operative and in full force and effect until June
3 thirtieth, one thousand nine hundred forty-seven.
