Senate Bill No. 4

(Originating in the Committee on Finance.)

[Passed March 23, 1946; in effect from passage.]

AN ACT to appropriate public moneys out of the state treasury for West Virginia University and other state colleges, and for the auditor's office to carry out the administration of any act of this session of the Legislature providing for the regulation of hospital service plans and medical service plans.

Be it enacted by the Legislature of West Virginia:

Section 1. *Additional Appropriations.*—That in addition
2 to the appropriations made by chapter eleven, acts of
3 the Legislature, regular session, one thousand nine hun-
4 dred forty-five, there be and are hereby appropriated out
5 of the treasury for the fiscal year ending June thirtieth,
6 one thousand nine hundred forty-six and for the fiscal

7 year ending June thirtieth, one thousand nine hundred
 8 forty-seven, the following sums of money for the follow-
 9 ing purposes:

Sec. 2. *Excess Collections.*—In addition to the amounts
 2 above appropriated each of the educational institutions
 3 of the state may with the approval of the budget director
 4 and the board of public works expend the amount of its
 5 excess collections as provided in section thirty-two, chap-
 6 ter thirty-nine, acts of the Legislature, regular session,
 7 one thousand nine hundred thirty-one.

Sec. 3. *Release of Appropriations for Certain State*
 2 *Educational Institutions.*—In view of the fact that the
 3 Interim Committee created under Senate Concurrent
 4 Resolution Number Six, regular session, one thousand
 5 nine hundred forty-five, has made to the Legislature a
 6 favorable report concerning the propriety of building the
 7 units specified in the appropriations hereinafter men-
 8 tioned, the Legislature hereby sanctions the immediate
 9 release for expenditure of the appropriations in items eight
 10 to eighteen, both inclusive, section three-a, title two, chap-

11 ter eleven, acts of the Legislature, regular session, one
12 thousand nine hundred forty-five. Upon the approval
13 of the budget director and the board of public works,
14 such appropriations or any part thereof may be expended
15 for the construction of buildings, or for the acquisition
16 of land and buildings, or for the purchase of equipment.

Sec. 4. *Expenditure of Appropriations Heretofore Made*
2 *for West Virginia University and Marshall College.*—The
3 Legislature hereby authorizes the expenditure of the
4 appropriations, or any part thereof, made for West Vir-
5 ginia University in item nineteen and for Marshall Col-
6 lege in item twenty-one, section three-a, title two, chapter
7 eleven, acts of the Legislature, regular session, one thou-
8 sand nine hundred forty-five, for the construction of
9 buildings, or for the acquisition of land and buildings, or
10 for the purchase of equipment, upon the approval of the
11 budget director and the board of public works.
