AN ACT authorizing the board of education of Wayne county, West Virginia, to submit to the voters of Westmoreland district, Wayne county, West Virginia, the question of the issuance and sale of bonds to construct a high school therein.

*Be it enacted by the Legislature of West Virginia:*

Section 1. *Wayne County Board of Education to*  
*2 Submit Question of Issuance of High School Bonds to*  
*3 Voters of Westmoreland District.*—That the board of  
4 education of Wayne county, West Virginia, may cause  
5 to be submitted to vote of the qualified electors of said  
6 Westmoreland district as provided by the general laws  
7 of the state, the question of the issuance and sale of  
8 bonds to purchase grounds, build high school buildings  
9 and furnish and equip the same when requested so to do

10 by a petition in writing, praying that bonds be issued  
11 and stating the purpose and the amount, thereof, signed  
12 by the legal voters of said Westmoreland magisterial  
13 district, equal to twenty per cent of the votes cast in  
14 said magisterial district for governor in the last preceding  
15 general election.

Sec. 2. *Amount of Bonds to be Issued.*—The bonds  
2 to be provided for hereunder shall not exceed in amount  
3 five per cent of the value of the taxable property therein,  
4 as shown by the last assessment, thereof, for state and  
5 county purposes, next prior to the issuance of said  
6 bonds.

Sec. 3. *Submission; Calling and Conducting Election.*  
2 —The order of submission, the calling of and conducting  
3 said election, declaring the results thereof, shall be in  
4 conformity to and with sections four, seven, eight, nine,  
5 ten, eleven, twelve, thirteen, fourteen, fifteen and sixteen,  
6 article one, chapter thirteen of the code of West Virginia,  
7 one thousand nine hundred thirty-one.

Sec. 4. *Advisory Committee to Board of Education.*  
2 —The board of education of Wayne county shall name

3 five citizens of Westmoreland district to serve in an ad-  
4 visory capacity to said board of education in the conduct  
5 of said election, issuance and sale of the bonds and in  
6 the construction of said high school from a list of names  
7 submitted to said board of education by the parent-  
8 teachers association of Westmoreland.
