ENROLLED Senate Bill No. 256

(By Mr. Eddy)

[Passed March 8, 1947; in effect July 1, 1947.]

AN ACT to amend and reenact chapter seventy-one, acts of the Legislature of West Virginia, one thousand nine hundred twenty-seven, relating to the erection of a high school building on the grounds of West Virginia University in Morgantown, by changing the name of such school from "University Rural High School" to a name to be selected as hereinafter provided and providing for its control and maintenance.

Be it enacted by the Legislature of West Virginia:

That chapter seventy-one, acts of the Legislature of West Virginia, one thousand nine hundred twenty-seven, be amended and reenacted to read as follows:

Section 1.—For the purpose of this act a high school

- 2 shall be defined as a school consisting of all grades above
- 3 the sixth to the completion of secondary education.

Sec. 2.—The name of the said high school shall be se-

- 2 lected jointly by the board of governors of the West Vir-
- 3 ginia university and the board of education of the county
- 4 of Monongalia.
 - Sec. 3.—The university board of governors and any other
- 2 controlling authorities of the university, as provided by
- 3 law, shall have general control and supervision of the said
- 4 high school as a part of West Virginia university.
 - Sec. 4.—The board of education of the county of Monon-
- 2 galia and the superintendent of schools of Monongalia
- 3 county shall constitute an advisory committee to confer
- 4 with the authorized agents of West Virginia university on
- 5 questions affecting the policy of the said high school.
 - Sec. 5.—The said high school may be used for observa-
- 2 tion, demonstration, directed teaching, practice super-
- 3 vision, and educational laboratory work of the college of
- 4 education of the West Virginia university.
 - Sec. 6.—The authorities of West Virginia university and
- 2 the advisory committee of Monongalia county as provided
- 3 for in section four, shall from year to year determine the

- 4 number of pupils to be admitted and the basis of pupil
- 5 selection.
 - Sec. 7.—The board of education of the county of Monon-
- 2 galia shall pay for maintenance and instruction of pupils
- 3 enrolled in the said high school a tuition fee of one-half
- 4 of the average per capita cost for instruction and main-
- 5 tenance, exclusive of transportation costs, in high schools
- 6 of West Virginia, as determined by the last preceding re-
- 7 port of the state superintendent of schools of West Vir-
- 8 ginia. The university board of governors and any other
- 9 authorities of the university, as provided by law, shall
- 10 provide the remainder of the cost of maintenance and
- 11 instruction.
 - Sec. 8.—With the approval of the university board of
 - 2 governors and any other authorities provided by law, the
 - 3 board of education of the county of Monongalia shall have
 - 4 the right to lay a levy for the erection of such additions
 - 5 and buildings as may be deemed necessary by all parties
 - 6 concerned to provide adequate facilities for said high
 - 7 school.
 - Sec. 9.—In the event that any gifts, bequests or federal

- 2 funds are made available to the board of education of the
- 3 county of Monongalia, for the benefit of said high school,
- 4 said board is hereby authorized to make said funds avail-
- 5 able to the proper authorities of the West Virginia uni-
- versity for the use designated.
 - Sec. 10.—All acts and parts of acts inconsistent with this
- 2 act are hereby repealed.
