AN ACT to amend and reenact section three, article thirteen, chapter eleven of the code of West Virginia, one thousand nine hundred thirty-one, as last amended by chapter ninety-five, acts of the Legislature, regular session, one thousand nine hundred forty-three, relating to tax on industrial loan companies.

Be it enacted by the Legislature of West Virginia:

That section three, article thirteen, chapter eleven of the code of West Virginia, one thousand nine hundred thirty-one, as last amended by chapter ninety-five, acts of the Legislature, regular session, one thousand nine hundred forty-three, relating to tax on industrial loan companies, be amended and reenacted to read as follows: Enr. Com. Sub. for S. B. No. 93] 2

Section 3. Exemptions; Non-Exempt Businesses .-2 There shall be an exemption in every case of fifty dollars in amount of tax computed under the provisions of 3 this article. A person exercising a privilege taxable 4. hereunder for a fractional part of a tax year shall be en-5 6 titled to an exemption of the sum bearing the proportions to fifty dollars that the period of time the privilege 7 is exercised bears to a whole year. Only one exemption 8 shall be allowed to any one person, whether he exer-9 cises one or more privileges taxable hereunder. 10

11 The provisions of this article shall not apply to: (a) Insurance companies which pay the state of West Vir-12 ginia a tax upon premiums: Provided, however, That 13 said exemption shall not extend to that part of the gross 14 income of insurance companies which is received for the 15 16 use of real property, other than property in which any such company maintains its office or offices, in this state, 17 whether such income be in the form of rentals or royal-18 ties; (b) persons engaged in the business of banking: 19 Provided, however, That said exemption shall not ex-2021 tend to that part of the gross income of such persons

22 which is received for the use of real property owned, 23other than the banking house or building in which the business of the bank is transacted, whether such income 24 25be in the form of rentals or royalties: (c) non-profit 26 cemetery companies organized and operated for the ex-27 clusive benefit of their members; (d) societies, organiza-28 tions and associations organized and operated for the ex-29clusive benefit of their members and not for profit; (e) 30 corporations, associations and societies organized and 31 operated exclusively for religious or charitable purposes: 32Provided, however, That the exemptions of this section shall not apply to corporations or cooperative associations 33 organized under the provisions of article four, chapter 34 35 nineteen of the code of West Virginia, one thousand nine 36hundred thirty-one, as amended; (f) building and loan 37 associations and federal savings and loan associations; 38 (g) Persons engaged in conducting the business of indus-39 trial loans under authority granted them by article seven of chapter thirty-one of the code of West Virginia, one 40 thousand nine hundred thirty-one: Provided, however, 41 42 That said exemption shall not extend to that part of the
