
WEST VIRGINIA LEGISLATURE

REGULAR SESSION, 1949





ENROLLED House Bill No. 398

(By MR. TRENT)

[Passed March 12, 1949; in effect ninety days from passage.]

AN ACT to provide for the submission to the voters of the state an amendment to the constitution of the state, to be known as the "Veterans' Bonus Amendment".

Be it enacted by the Legislature of West Virginia:

Section 1. Submitting "Veterans' Bonus Amendment"
2 to the State Constitution.—That the question of the rati3 fication or rejection of an amendment to the constitution
4 of West Virginia, proposed in accordance with the provi5 sions of section two, article fourteen of said constitution,
6 shall be submitted to the voters of the state at the next
7 general election, to be held in the year one thousand nine
8 hundred fifty, which proposed amendment is as follows:

Veterans' Bonus Amendment

10 The Legislature shall by law provide for the issuance11 and sale of state bonds, not to exceed in the aggregate

ninety million dollars, which shall be in addition to all 12 other state bonds heretofore authorized. The proceeds 13 of such additional bonds, or so many thereof as may be 14 15 necessary for the purpose, shall be used and appropriat-16 ed solely for the purpose of paying a cash bonus to 17 veterans of World War I and World War II. Such bonus shall be paid to all persons who rendered active service 18 19 in the armed forces of the United States in World War I 20between the sixth day of April, one thousand nine hun-21dred seventeen, and the eleventh day of November, one 22 thousand nine hundred eighteen, both dates inclusive, 23or in World War II between the seventh day of December, one thousand nine hundred forty-one, and the sec-24 25 ond day of September, one thousand nine hundred forty-26 five, both dates inclusive, or in both such wars, who were 27 bona fide residents of the State of West Virginia at the time of their entry into such service and for a period 28 of at least six months prior thereto, who were not dis-29 30honorably discharged from such forces, and who within the periods specified above actively served in such armed 31 32forces for a period of at least ninety days. Such a bonus

33 shall also be paid to any disabled veteran, otherwise 34 qualified, who was discharged within ninety days after entering the services because of a service connected dis-35 36ability. The amount of such bonus shall be calculated on the basis of ten dollars for each month, or major frac-37 tion thereof, served within the territorial limits of the 38 39 forty-eight states and the District of Columbia, and fif-40 teen dollars for each month, or major fraction thereof, served outside such limits, but such amount shall in no 41 case exceed three hundred dollars for those who served 42 only within the territorial limits specified above, and 43four hundred dollars for those who served outside such 44 45 limits. The bonus to which any deceased veteran would be entitled, if living, shall be paid only to the following 46 surviving relatives of such veteran, if such relatives are 47 residents of this State when application for payment is 48 made: Any unremarried widow, or if none, any child 49 50 or children under the age of sixteen, or if none, any dependent parent or parents. 51

52 Whenever the Legislature shall provide for the issuance 53 of any bonds under the authority of this amendment, it

shall at the same time provide for the levy and collection of an additional cigarette tax, or an additional tax on nonintoxicating beer, or an additional charge on the sale of each bottle of wine and liquor, or an additional general consumers sales tax, or a graduated income tax, or any two or more thereof, in such amount as may be required to pay annually the interest on such bonds and the principal thereof within and not exceeding thirty years.

Sec. 2. Amendment to be Known as the "Veterans'
2 Bonus Amendment".—For convenience in referring to
3 said proposed amendment, and in the preparation of the
4 form of the ballot hereinafter provided for, said proposed
5 amendment is hereby designated as the "Veterans Ninety
6 Million Dollars Bonus Amendment".

Sec. 3. Form of Ballot: Election.—For the purpose of 2 enabling the voters of the state to vote on the question 3 of said proposed amendment to the constitution at the 4 said general election to be held in the year one thousand 5 nine hundred fifty, the board of ballot commissioners 6 of each county is hereby required to place upon, and at

7 the foot of, the official ballot to be voted at that election,8 the following:

9 Ballot on "Veterans' \$90,000,000 Bonus Amendment".
10 (The Bonus Bonds to be Retired by Additional Taxes.)
11 For ratification of Veterans' \$90,000,000.00 Bonus
12 Amendment.

13 Against ratification of Veterans' \$90,000,000.00 Bonus
14 Amendment.

The said election on the proposed amendment at each 15 16 place of voting shall be superintended, conducted and returned, and the result thereof ascertained by the same 17 officers and in the same manner as the election of officers 18 to be voted for at said election, and all the provisions 19 of the law relating to general elections, including all 2021 duties to be performed by any officer or board, as far 22 as practicable, and not inconsistent with anything here-23in contained, shall apply to the election held under the provisions of this act, except when it is herein otherwise 24 25provided. The ballots cast on the question of said pro-26 posed amendment shall be counted as other ballots cast at said election. 27

Sec. 4. Certificates of Election Commissioners; Canvass 2 of Vote; Certifying Result.—As soon as the result is as-3 certained, the commissioners, or a majority of them, 4 and the canvassers (if there be any), or a majority of 5 them, at each place of voting, shall make out and sign 6 two certificates thereof in the following form or the 7 following effect:

"We, the undersigned, who acted as commissioners 8 (or canvassers, as the case may be) of the election held 9 at Precinct No. ____, in the district of 10 in the county of _____, on the 11 day of _____, one thousand nine hun-12dred fifty, upon the question of the ratification or rejec-13 14 tion of the proposed constitutional amendment, do hereby certify that the result of said election is as follows: 15 16 "For ratification of Veterans' Ninety Million Dollars Bonus Amendment votes, 17 18 "Against ratification of Veterans' Ninety Million Dollars

19 Bonus Amendment votes.

20 "Given under our hands this _____ day of _____,

21 one thousand nine hundred fifty."

22 The said two certificates shall correspond with each other in all respects and contain the full and true re-23 24 turns of said election at each place of voting on said question. The said commissioners, or any one of them 25 (or said canvassers or any one of them, as the case may 26 be), shall, within four days, excluding Sunday, after 27 that on which said election was held, deliver one of 28 29 said certificates to the clerk of the county court of his 30county, together with the ballots, and the other to the 31 clerk of the circuit court of the county.

32 The said certificates, together with the ballots cast on the question of said proposed amendment, shall be laid 33 before the commissioners of the county court at the court 34 35 house at the same time the ballots, poll books, and the 36 certificates of election of the members of the Legislature 37 are laid before them; and as soon as the result of said 38 election in the county upon the question of such ratification or rejection is ascertained, two certificates of such 39 result shall be made out and signed by said commission-40 41 ers as a board of canvassers, in the form or to the following 42 effect:

51 "For ratification of Veterans' Ninety Million Dollars52 Bonus Amendment votes.

53 "Against ratification of Veterans' Ninety Million Dollar

54 Bonus Amendment votes.

55 "Given under our hands this _____ day of _____,56 one thousand nine hundred fifty."

57 One of the certificates shall be filed in the office of the 58 clerk of the county court, and the other forwarded by 59 mail to the secretary of state, who shall file and pre-60 serve the same until the day on which the result of said 61 election in the state is to be ascertained, as hereinafter 62 stated.

Sec. 5. Proclamation of Result of Election by Gov-

2 ernor.—On the twenty-fifth day after the election is held, 3 or as soon thereafter as practicable, the said certificate shall be laid before the governor, whose duty it shall be 4 5 to ascertain therefrom the result of said election in the state, and declare the same by proclamation published 6 in one or more newspapers printed at the seat of gov-7 ernment. If a majority of the votes cast at said election 8 upon said question be for ratification of said amendment, 9 the proposed amendment so ratified shall be in force 10 and effect from and after the time of such ratification. 11 12 as part of the constitution of the state.

Sec. 6. Publication of Proposed Amendment by Governor.—The governor shall cause the said proposed amend-2 3 ment, with the proper designation for the same as hereinbefore adopted, to be published one time at least 4 three months before such election in some newspaper 5 in every county in which a newspaper is printed, at a 6 7 price to be agreed upon in advance, in writing, and the cost of such advertising shall in the first instance, if found 8 necessary by him, be paid out of the governor's con-9 10 tingent fund and be afterwards repaid to such fund by appropriation of the Legislature. 11
