AN ACT to amend and reenact section eighteen, article four, chapter thirty of the code of West Virginia, one thousand nine hundred thirty-one, as amended, relating to practicing dentistry or dental hygiene without complying with provisions of this article; penalty; and injunction.

*Be it enacted by the Legislature of West Virginia:*

That section eighteen, article four, chapter thirty of the code of West Virginia, one thousand nine hundred thirty-one, as amended, be amended and reenacted to read as follows:

Section 18. *Practicing Dentistry or Dental Hygiene*  
2 *without Complying with Provisions of This Article;*  
3 *Penalty; Injunction.*—Any person who shall practice or  
4 offer to practice dentistry or dental hygiene in this state

5 without first having complied with the provisions of this  
6 article, or who shall violate any of its provisions for which  
7 no specific penalty has been provided, shall be guilty of  
8 a misdemeanor, and, upon conviction thereof, shall be  
9 fined not less than fifty nor more than five hundred  
10 dollars, or may be confined in jail for not more than  
11 thirty days, or both, at the discretion of the court. Each  
12 act of dentistry or dental hygiene shall be deemed a sep-  
13 arate offense and shall constitute a practice of dentistry  
14 or dental hygiene within the meaning of this section, and  
15 each day that a person may hold himself out as practicing  
16 in his own name or any name shall be deemed a separate  
17 offense.

18 Notwithstanding the existence of any other remedy,  
19 the board may, in the manner provided by law, main-  
20 tain an action for an injunction against any person,  
21 partnership, or association to restrain or prevent the  
22 practice of dentistry and/or dental hygiene when such  
23 person, partnership, or association repeatedly refuses to  
24 obtain registration or license therefor and continues the  
25 practice of dentistry and/or dental hygiene without first

26 obtaining registration or license therefor in the manner  
27 hereinbefore provided.






