[Passed February 3, 1956; in effect from passage.]

AN ACT finding and declaring certain claims against the state
and its agencies to be moral obligations of the state, and
directing the auditor to issue warrants for the payment
thereof.

Be it enacted by the Legislature of West Virginia:

Section 1. *Finding and Declaring Certain Claims Against*
2 *the State Adjutant General, State Board of Controls,*
3 *State Road Commission, State Tax Commissioner and*
4 *West Virginia University, to Be Moral Obligations of the*
5 *State, and Directing Payment thereof.—The Legislature*

6 has considered the findings of fact and recommendations
7 reported to it by the attorney general concerning various
8 claims against the state and agencies thereof, and in re-
9 spect to each of the following claims the Legislature
10 adopts those findings of fact as its own, and hereby de-
11 clares it to be the moral obligation of the state to pay
12 each such claim in the amount specified below, and directs
13 the auditor to issue warrants for the payment thereof
14 out of any fund appropriated and available for the pur-
15 pose.
