House Bill No. 124

(By MR. POWELL)

[Passed March 1, 1957; in effect July 1, 1957.]

AN ACT to amend and reenact section five-a, article twelve, chapter sixty-two of the code of West Virginia, one thousand nine hundred thirty-one, as amended, relating to probation officers of the second judicial circuit, third judicial circuit, fourteenth judicial circuit and of Wayne County; salary and expenses.

Be it enacted by the Legislature of West Virginia:

That section five-a, article twelve, chapter sixty-two of the code of West Virginia, one thousand nine hundred thirty-one, as amended, be amended and reenacted to read as follows:

Section 5-a. *Probation Officers of Second Judicial Circuit, Third Judicial Circuit, Fourteenth Judicial Circuit and of Wayne County; Salary and Expenses.*—The judge of the circuit courts of the second judicial circuit, third judicial circuit, fourteenth judicial circuit and of the

6 circuit court of Wayne county in the twenty-fourth ju-
7 dicial circuit each is authorized to appoint a court pro-
8 bation officer to serve during the pleasure of the appoint-
9 ing judge, without first obtaining approval of the county
10 courts of the counties of said judicial circuits and of
11 Wayne county, respectively, as provided in section five
12 of the article. Such appointment shall be effective upon
13 the entry of the appointment order in the court order
14 book. A certified copy of said order shall be delivered
15 to the county court of each of the counties concerned
16 and said county courts respectively, shall arrange for and
17 appropriate funds for payment of and shall pay the salary
18 and expenses of such probation officer in a manner con-
19 sistent with contribution provisions of said section five.
20 The probation officers so appointed shall have and may
21 exercise all of the powers and perform all the duties and
22 services of probation officers as provided in this article.
