## ENROLLED Senate Bill No. 48

(By Mr. TRAUBERT)

[Passed March 4, 1959; in effect from passage.]

AN ACT to amend and reenact section one, article eight-a, chapter sixteen of the code of West Virginia, one thousand nine hundred thirty-one, as amended, relating to definitions of certain words and phrases dealing with narcotic drugs.

Be it enacted by the Legislature of West Virginia:

That section one, article eight-a, chapter sixteen of the code of West Virginia, one thousand nine hundred thirty-one, as amended, be amended and reenacted to read as follows:

- Section 1. Definitions.—The following words and
- 2 phrases, as used in this article, shall have the following
- 3 meanings, unless the context otherwise requires:

- 4 (1) "Person" includes any corporation, association, co-
- 5 partnership or one or more individuals.
- 6 (2) "Physician" means a person authorized by law to
- 7 practice medicine in this state and any other person au-
- 8 thorized by law to treat sick and injured human beings
- 9 in the state and to use narcotic drugs in connection with
- 10 such treatment.
- 11 (3) "Dentist" means a person authorized by law to
- 12 practice dentistry in this state.
- 13 (4) "Veterinarian" means a person authorized by law
- 14 to practice veterinary medicine in this state.
- 15 (5) "Manufacturer" means a person who, by compound-
- 16 ing, mixing, cultivating, growing, or other process, pro-
- 17 duces or prepares narcotic drugs, but does not include a
- 18 pharmacist who compounds narcotic drugs to be sold or
- 19 dispensed on prescriptions.
- 20 (6) "Wholesaler" means a person who supplies narcotic
- 21 drugs that he himself has not produced or prepared, on
- 22 official written orders, but not prescriptions.
- 23 (7) "Pharmacist" means a licensed pharmacist as de-
- 24 fined by the laws of this state.

- 25 (8) "Pharmacy owner" means the owner of a store or
- 26 other place of business where narcotic drugs are com-
- 27 pounded or dispensed by a registered pharmacist; but
- 28 nothing in this article contained shall be construed as
- 29 conferring on a person who is not registered or licensed
- 30 as a pharmacist any authority, right or privilege that is
- 31 not granted to him by the pharmacy laws of this state.
- 32 (9) "Hospital" means an institution for the care and
- 33 treatment of the sick and injured, approved by the state
- 34 board of pharmacy as proper to be entrusted with the cus-
- 35 tody of narcotic drugs and the professional use of nar-
- 36 cotic drugs under the direction of a physician, dentist or
- 37 veterinarian.
- 38 (10) "Laboratory" means a laboratory approved by the
- 39 state board of pharmacy as proper to be entrusted with the
- 40 custody of narcotic drugs and the use of narcotic drugs for
- 41 scientific and medical purposes and for purposes of in-
- 42 struction.
- 43 (11) "Sale" includes barter, exchange, or offer there-
- 44 for, and each such transaction made by any person,

- 45 whether as principal, proprietor, agent, servant or em-
- 46 ployee.
- 47 (12) "Coca leaves" includes cocaine and any compound,
- 48 manufacture, salt, derivative, mixture, or preparation of
- 49 coca leaves, except derivatives of coca leaves which do not
- 50 contain cocaine, ecognine, or substances from which co-
- 51 caine or ecognine may be synthesized or made.
- 52 (13) "Opium" includes morphine, codeine, and heroin,
- 53 and any compound, manufacture, salt, derivative, mixture
- 54 or preparation of opium.
- 55 (14) "Cannabis" includes all parts of the plant cannabis
- 56 sativa L., whether growing or not; the seeds thereof; the
- 57 resin extracted from any part of the plant; and every
- 58 compound, manufacture, salt, derivative, mixture, or prep-
- 59 aration of such plant, its seeds, or resin; but shall not in-
- 60 clude the mature stalks of such plant, fiber produced from
- 61 such stalks, oil or cake made from the seeds of such plant,
- 62 or any other compound, manufacture, salt, derivative,
- 63 mixture, or preparation of such mature stalks (except the
- 64 resin extracted therefrom), fiber, oil, or cake, of the ster-

- 65 ilized seed of such plant which is incapable of germina-
- 66 tion.
- 67 (15) "Narcotic drugs" means coca leaves, opium, isoni-
- 68 pecaine, cannabis, and every other substance neither
- 69 chemically nor physically distinguishable from them, and
- 70 any other drugs to which the federal laws relating to nar-
- 71 cotic drugs may now apply, and any drug hereafter found
- 72 by the state board of pharmacy to have an addiction-
- 73 forming or addiction-sustaining liability similar to mor-
- 74 phine or cocaine.
- 75 (16) "Federal narcotic laws" means the laws of the
- 76 United States relating to opium, coca leaves, cannabis, and
- 77 other narcotic drugs.
- 78 (17) "Official written order" means an order written
- 79 on a form provided for that purpose by the United States
- 80 commissioner of narcotics, under any laws of the United
- 81 States making provision therefor, if such order forms are
- 82 authorized and required by federal law, and if no such or-
- 83 der form is provided, then on an official form provided for
- 84 that purpose by the state board of pharmacy.

- 85 (18) "Dispense" includes distribute, leave with, give
- 86 away, dispose of, or deliver.
- 87 (19) "Registry number" means the number assigned to
- 88 each person registered under the federal narcotic laws.
- 89 (20) "Isonipecaine" means the substance identified
- 90 chemically as 1-methyl-4-phenyl-piperidine-4-carboxylic
- 91 acid ethyl ester, or any salt thereof, by whatever trade
- 92 name identified.
