AN ACT to authorize the county court of Marion county, West Virginia, to establish and maintain a special fund to be known as the "Airport Fund", and to use and transfer to said airport fund unexpended funds and surpluses in any fund of said county, and to raise and deposit in said fund all money that may be raised from tax levies and appropriations made, provided and authorized for that purpose, and within the constitutional limitations, and all money and income derived from the operation of an airport in this county or in other counties in this state, operated jointly with another or other counties or a public agency known as "Benedum Airport Authority", and all grants, appro-

priations, gifts, donations and financial assistance made to said airport by the state of West Virginia, or the United States government, or any person, firm or corporation, and to use said fund for the acquisition, construction, maintenance, improvement, operation, or leasing of an airport in Marion county or in other counties in this state operated jointly with another or other counties, or a public agency known as "Benedum Airport Authority", and to annually transfer from said fund to the general county fund any money in said fund not needed for airport purposes.
