AN ACT to make supplementary appropriation of public  
moneys out of the state treasury for the state department  
of welfare.

*Be it enacted by the Legislature of West Virginia:*

Section 1. *Supplementary Appropriation.*—In addition  
2 and as a supplement to the appropriation made by the  
3 Enrolled Budget Bill enacted by the Legislature of West  
4 Virginia, regular session, one thousand nine hundred  
5 sixty-one, there is hereby appropriated from the state  
6 fund, general revenue, conditionally upon the fulfillment

7 of the provisions set forth in chapter thirty-nine, acts of  
 8 the Legislature of West Virginia, regular session, one  
 9 thousand nine hundred thirty-nine, as amended, the fol-  
 10 lowing additional sums of money for the purposes  
 11 hereinafter stated:



21    This supplementary appropriation shall be paid out of  
 22 surplus funds in the state fund, general revenue, as  
 23 evidenced by a revised revenue statement submitted to  
 24 the Legislature by the board of public works under date  
 25 of June sixteenth, one thousand nine hundred sixty-one,  
 26 in accordance with the provisions of article six, section

27 fifty-one of the state constitution. This supplementary  
28 appropriation shall implement through the state depart-  
29 ment of welfare this state's participation in the new fed-  
30 eral program of aid to dependent children of unemployed  
31 parents.




