## House Bill No. 80

(By Mr. Bedell)

[Passed March 7, 1961; in effect from passage.]

AN ACT to amend and reenact section one, article fourteen, chapter eleven of the code of West Virginia, one thousand nine hundred thirty-one, as amended, relating to the definition of gasoline.

Be it enacted by the Legislature of West Virginia:

That section one, article fourteen, chapter eleven of the code of West Virginia, one thousand nine hundred thirty-one, as amended, be amended and reenacted to read as follows:

Section 1. Definitions; Gasoline, Person, Company, Dis-

- 2 tributor, Retail Dealer, Importer, Sale, Purchase and
- 3 Motor Vehicles.—When used in this article: The term
- 4 "gasoline" shall include any substance or combination of
- 5 substances which is capable of use as a motor fuel for
- 6 any internal combustion engine, except fuel oil, kerosene,
- 7 cleaner's solvent, and any other liquid petroleum product

- 8 not commonly used as a motor fuel, when not used or
- 9 sold for use as a motor fuel in an internal combustion
- 10 engine: Provided, however, That the term "gasoline" shall
- 11 not include diesel fuel, fuel oil or kerosene when used or
- 12 sold for use as a motor fuel to operate railroad diesel loco-
- 13 motives in this state or when used as a motor fuel to oper-
- 14 ate water-craft operated upon the navigable streams of
- 15 this state, nor include any fuel of a type sold exclusively
- 16 as a motor fuel to operate aircraft.
- 17 The term "person" or the term "company" shall include
- 18 any individual, firm, copartnership, joint venture, associa-
- 19 tion, corporation, trust and any other group or combina-
- 20 tion acting as a unit, and the plural as well as the singular
- 21 number, unless the intention to give a more limited mean-
- 22 ing is disclosed by the context, and when used in connec-
- 23 tion with the penalties imposed by this article, shall mean
- 24 and include the officers, directors, trustees, or members of
- 25 any firm, copartnership, joint venture, association, corpo-
- 26 ration, trust or any other group acting as a unit.
- 27 The term "distributor" shall mean and include every
- 28 person who refines, produces, manufactures, compounds, or

- 29 blends gasoline in this state for use or for sale to jobbers or
- 30 consumers, and every person who is now engaged, or who
- 31 may hereafter engage, in his own name or in the name of
- 32 his representative or agent in this state, in the selling of
- 33 gasoline for the purpose of resale or distribution; and per-
- 34 sons operating tank wagons into this state from places of
- 35 business located outside this state and selling gasoline in
- 36 quantities as desired by purchasers in this state without
- 37 definite orders having been placed prior to the delivery of
- 38 the product, shall be deemed distributors in this state.
- 39 The term "retail dealer" shall mean and include any
- 40 person not a distributor who sells gasoline in this state
- 41 to consumers only.
- 42 The term "importer" shall mean any person who pur-
- 43 chases or obtains gasoline in the amount of twenty-five
- 44 gallons or more outside this state and uses the same within
- 45 the state.
- 46 The term "sale" shall include any exchange, gift, or
- 47 other disposition, and "purchase" shall include any acqui-
- 48 sition of ownership.
- 49 The term "motor vehicle" shall mean automobiles,

- 50 motor trucks and motorcycles, and shall include all
- 51 other vehicles, engines or machines which are operated
- 52 or propelled by combustion of gasoline.
