AN ACT to authorize and empower the board of education of the county of Tyler, West Virginia, to transfer a certain parcel of land, owned by said board of education, to the Friendly community activities association, inc., a nonprofit, public benefit corporation.

Be it enacted by the Legislature of West Virginia:

Section 1. The Board of Education of the County of Tyler Authorized to Transfer a Certain Parcel of its Real Property to the Friendly Community Activities Association, Inc.—Inasmuch as the Parent-Teacher Association of the Friendly school at Friendly, Union district, Tyler county, West Virginia, caused to be erected at the expense of said association a gymnasium building upon real property owned by the board of education of the county Enr. H. B. No. 947]

of Tyler, West Virginia, with the consent and under-9 10 standing of said board of education that the said building would be used for both public school functions and com-11 munity functions and there has been formed the Friendly 12 13 community activities association, inc., a non-profit, public benefit corporation, which has among its declared 14 purposes the power to hold title to real property to be 15 used for community and other public purposes, and both 16 17 the said board of education and the said parent-teacher 18 association are desirous of transferring and conveying the 19 real property upon which said gymnasium building is 20 situate to the said Friendly community activities association, inc., to be used for community activities, for pub-21 lic education uses and other public purposes, the board 22 of education of the county of Tyler, state of West Vir-2324 ginia, is hereby authorized and empowered to convey 25and transfer to the Friendly community activities association, inc., a non-profit, public benefit corporation, 2627 of Friendly, West Virginia, to be used for community activities, public education and other public purposes, a 28 29 certain tract or parcel of real estate, together with all im-

provements thereon, and rights and appurtenances there-30 unto belonging, situate in the town of Friendly, Union 31 32 district, Tyler county, West Virginia, and bounded and described as follows, to wit: Beginning at a point in the 33 east right-of-way line of West Virginia State Route 2 34 at a concrete marker designated FCAA-1, which said be 35 beginning point is also the westerly line of the property 36 of the board of education of Tyler county; thence with 37 38 the easterly right-of-way line of said State Route 2 in a 39 southwesterly direction a distance of 61.5 feet to a concrete marker designated FCAA-2, located at the corner 40 41 of the property owned by said board of education; thence leaving said State Route 2 and with the line of the prop-42 43 erty of said board of education south 38 degrees 45 44 minutes east 146.7 feet to a concrete marker designated FCAA-3; thence north 40 degrees 0 minutes east 68.5 feet 45 to a concrete marker designated FCAA-4; thence north 46 41 degrees 0 minutes west 146.5 feet to the place of begin-47 ning, containing nine thousand five hundred twenty-nine 48 (9,529) square feet or .219 acres, more or less. 49

without cost to said board of education and said board of education retains the right to use said building and real property for public education purposes and said property is to be used for community activities and other public purposes in addition to public education, the said board of education is authorized to make such conveyance and transfer without monetary consideration being paid by the Friendly community activities association, inc., to the said board of education.
