AN ACT to amend article five, chapter eighteen of the code of West Virginia, one thousand nine hundred thirty-one, as amended, by adding thereto a new section, designated section seven-a, relating to the sale or exchange of school property included in federal flood control projects to the United States of America, its instrumentalities, agencies or political subdivisions.

Be it enacted by the Legislature of West Virginia:

That article five, chapter eighteen of the code of West Virginia, one thousand nine hundred thirty-one, as amended, be

seven-a, to read as follows:

Section 7-a. Disposition of School Property in Flood Con-

trol Projects.—If at any time the board shall ascertain that any land or part thereof then being used for school purposes is to be included in any federal flood control project the board may (a) sell, dismantle, remove or re-6 locate any buildings thereon; (b) contract with the United States of America, or any instrumentality, agency or political subdivision thereof, for the sale or exchange of its interest in such land or any part thereof; and (c) without auction sell or exchange its interest in such land or 10 11 any part thereof to the United States of America, or any instrumentality, agency or political subdivision thereof, 12 in accordance with the terms and provisions of such con-13 tract. Notwithstanding the provisions of section seven of 14 this article, neither the grantor of such land or any part 15 thereof nor his heirs or assigns shall have the right to 16 17 purchase said land or any part thereof or have any other 18 rights whatever under section seven of this article.
