**Senate Bill No. 1**

(By MR. CARSON, MR. PRESIDENT, AND MR. BARNETT)

[Passed February 24, 1967; in effect from passage.]

AN ACT to amend and reenact section one, article three, chapter seventeen of the code of West Virginia, one thousand nine hundred thirty-one, as amended, relating to the state road fund, payments into said fund and providing for the use of the money in said fund.

*Be it enacted by the Legislature of West Virginia:*

That section one, article three, chapter seventeen of the code of West Virginia, one thousand nine hundred thirty-one, as amended, be amended and reenacted to read as follows:

**ARTICLE 3. STATE ROAD FUND.**

**§17-3-1. What constitutes fund; payments into fund; use of money in fund.**

There shall be a state road fund, which shall consist of  
2 the proceeds of all state license taxes imposed upon auto-

3 mobiles or other motor or steam driven vehicles; the  
4 registration fees imposed upon all owners, chauffeurs,  
5 operators, and dealers in automobiles or other motor  
6 driven vehicles; all sums of money which may be donated  
7 to such fund; all proceeds derived from the sale of state  
8 bonds issued pursuant to any resolution or act of the  
9 Legislature carrying into effect the "Better Roads Amend-  
10 ment" to the constitution of this state, adopted in the  
11 month of November, one thousand nine hundred sixty-  
12 four, except that the proceeds from the sale of these bonds  
13 shall be kept in a separate and distinct account in the  
14 state road fund; all moneys and funds appropriated to it  
15 by the Legislature; and all moneys allotted or appro-  
16 priated by the federal government to this state for road  
17 construction and maintenance pursuant to any act of the  
18 congress of the United States; the proceeds of all taxes  
19 imposed upon and collected from any person, firm or  
20 corporation and of all taxes or charges imposed upon and  
21 collected from any county, district or municipality for  
22 the benefit of such fund; the proceeds of all judgments,  
23 decrees or awards recovered and collected from any per-

24 son, firm or corporation for damages done to, or sustained  
25 by, any of the state roads or parts thereof; all moneys  
26 recovered or received by reason of the violation of any  
27 contract respecting the building, construction or mainten-  
28 ance of any state road; all penalties and forfeitures im-  
29 posed, recovered or received by reason thereof; and any  
30 and all other moneys and funds appropriated to, imposed  
31 and collected for the benefit of such fund, or collected by  
32 virtue of any statute and payable to such fund.

33     When any money is collected from any of the sources  
34 aforesaid, it shall be paid into the state treasury by the  
35 officer whose duty it is to collect and account for the same,  
36 and credited to the state road fund, and shall be used only  
37 for the purposes named in this chapter, that is to say: (a)  
38 To pay the principal and interest due on all state bonds  
39 issued for the benefit of said fund, and set aside and  
40 appropriated for that purpose; (b) to pay the expenses of  
41 the administration of the road department; (c) to pay the  
42 cost of maintenance, construction, reconstruction and  
43 improvement of all state roads.
