AN ACT to amend and reenact section nine, article twentyone, chapter eleven of the code of West Virginia, one thousand nine hundred thirty-one, as amended, relating to the determination of the meaning of terms used in the West Virginia personal income tax act.

Be it enacted by the Legislature of West Virginia:

That section nine, article twenty-one, chapter eleven of the code of West Virginia, one thousand nine hundred thirty-one, as amended, be amended and reenacted to read as follows: ARTICLE 21. PERSONAL INCOME TAX.

§11-21-9. Meaning of terms.

1 Any term used in this article shall have the same mean-2 ing as when used in a comparable context in the laws Enr. H. B. No. 238]

3 of the United States relating to income taxes, unless 4 a different meaning is clearly required. Any reference 5 in this article to the laws of the United States shall mean the provisions of the Internal Revenue Code of 6 7 1954, as amended, and such other provisions of the laws 8 of the United States as relate to the determination of 9 income for federal income tax purposes. All amendments made to the laws of the United States prior to 10 the first day of January, one thousand nine hundred 11 sixty-eight, shall be given effect in determining the taxes 12 13 imposed by this article for the tax period beginning the 14 first day of January, one thousand nine hundred sixty-15 eight, and thereafter, but no amendment to the laws of the United States made on or after the first day of Janu-16 17 ary, one thousand nine hundred sixty-eight, shall be 18 given effect.
