An ACT to amend and reenact section one, article four, chapter thirty-five of the code of West Virginia, one thousand nine hundred thirty-one, as amended, relating to the disposition of property of subordinate lodges of Odd Fellows, Knights of Pythias or Order of Eagles.

Be it enacted by the Legislature of West Virginia:

That section one, article four, chapter thirty-five of the code of West Virginia, one thousand nine hundred thirty-one, as amended, be amended and reenacted to read as follows:

ARTICLE 4. PROVISIONS REGARDING PARTICULAR FRA-TERNAL ORGANIZATIONS.

§35-4-1. Disposition of property of subordinate lodge of Odd Fellows, Knights of Pythias or Order of Eagles.

1 If any subordinate lodge of the Independent Order

2 of Odd Fellows, the order Knights of Pythias or Fraternal Order of Eagles, in this state, working under the 3 respective jurisdiction of the parent grand lodge of said 4 respective orders, for this state, shall disband, surrender 5 or forfeit its charter and cease to work, all its property, 6 real and personal, shall, immediately upon such dis-7 banding, surrender or forfeiture, vest in the said respec-8 tive parent grand lodge, having jurisdiction over said 9 10 subordinate lodge, to be held by that body for the charitable uses of the said respective parent grand lodge, in 11 this state, according to the rules, regulations and policy 12 of the grand lodge concerned, and said respective parent 13 14 grand lodge is authorized in its corporate name, to sue 15 for and recover such property, real and personal.
