AN ACT to amend and reenact section one, article five, chapter twenty-six of the code of West Virginia, one thousand nine hundred thirty-one, as amended, relating to state benevolent institutions; continuation; management; superintendent; and renaming of Pinecrest sanitarium.

*Be it enacted by the Legislature of West Virginia:*

That section one, article five, chapter twenty-six of the code of West Virginia, one thousand nine hundred thirty-one, as amended, be amended and reenacted to read as follows:

**ARTICLE 5. PINECREST HOSPITAL.**

**§26-5-1. Continuation; management; superintendent.**

- 1 The tuberculosis sanitarium heretofore established at
- 2 Beckley, for the care and treatment of persons afflicted

3 with tuberculosis, shall be continued and shall be known  
4 as Pinecrest hospital, and shall be managed, directed and  
5 controlled as prescribed in article one, chapter twenty-  
6 five, and in section eight, article one, chapter sixteen of  
7 the code. The chief executive officer of such hospital  
8 shall be the superintendent, who shall be a legally quali-  
9 fied physician of at least six years' experience in the  
10 practice of his profession and who shall be a person of  
11 good executive ability.
