[Passed February 12, 1970; in effect from passage.]

AN ACT to amend article one, chapter seven of the code of West Virginia, one thousand nine hundred thirty-one, as amended, by adding thereto a new section, designated section three-o, authorizing and empowering county courts to construct, reconstruct, establish, acquire, improve, renovate, extend, enlarge, increase, own, equip, repair, replace, maintain and operate transportation terminals, county and other public facilities and motor vehicle parking facilities; providing that the power and authority conferred upon such county courts may be exercised by such county courts directly or may be delegated to commissions or boards; and authorizing the issuance of county

general obligation bonds for such purposes if approved by the voters of the county as provided by law.

Be it enacted by the Legislature of West Virginia:

That article one, chapter seven of the code of West Virginia, one thousand nine hundred thirty-one, as amended, be amended by adding thereto a new section, designated section three-o, to read as follows:

ARTICLE 1. COUNTY COURTS GENERALLY.

§7-1-3o. Authority to construct and maintain county transportation, parking, and other public facilities; authority to create a board or commission; financing.

1 In addition to all other powers and duties now con-
2 ferred by law upon county courts, such courts are here-
3 by authorized and empowered to construct, reconstruct,
4 establish, acquire, improve, renovate, extend, enlarge,
5 increase, own, equip, repair (including replacement),
6 maintain and operate transportation terminals, county and
7 other public facilities and motor vehicle parking facili-
8 ties (including parking lots, buildings, ramps, curblines
9 parking, meters and other facilities deemed necessary,

10 appropriate, useful, convenient or incidental to the regu-
11 lation, control and parking of motor vehicles).

12 The power and authority conferred upon the county
13 courts in this section may be exercised by the county
14 courts directly or may be delegated to commissions or
15 boards created by the county courts for this purpose.

16 In order to pay for all costs and expenses incurred
17 in carrying out the provisions of this section, any county
18 court is authorized to issue general obligation bonds of
19 the county if the issuance thereof has been authorized
20 by the voters of such county as provided by law.
